A large infrastructure project such as setting up of laboratories or new plants. It will be the personal responsibility of the HODs/Directors to ensure that the desired administrative set up is approved at the appropriate level.

3. Administrative / Technical Sanction:- After the preparation of the DPR, the technical sanction would be taken from appropriate competent authority. This will depend on the cost of the project.

Minutes of the State Level Sanctioning Committee (SLSC) meeting held on 25<sup>th</sup> June, 2014 to consider the projects under RKVY stream -I for the year 2014-15.

Meeting of the State Level Sanctioning Committee was held on 25<sup>th</sup> June, 2014 under the chairmanship of Chief Secretary, Government of Madhya Pradesh to consider the projects under Rashtriya Krishi Vikas Yojna (RKVY) for the year 2014-15 under Stream - I. The list of participant is at <u>Annexure-1</u>.

The committee discussed the agenda and the proposed projects in the light of observation made by GoI, MoA and circulated vide their letter No. 1-14/2014-RKVY dated 24<sup>th</sup> June 2014. Discussions on each of the agenda points are as follows:-

#### **AGENDA**

- 1. The committee reviewed the current status of expenditure for the year 2012-13 and 2013-14 along with the utilization certificate submitted to GoI. The Chief Secretary expressed his concern on the balance available with the departments and directed them to submit the balance utilization certificate within next three months time, so as to avoid delay in getting second installment of 2014-15. All the departments were also asked to review why 60% the allocation could not be spent last year and apprise in the next meeting.
- 2. Ex-Post Facto approval of various projects sanctioned during the year 2013-14. The committee approved all the projects which were sanctioned by the Chief Secretary in anticipation of approval of SLSC during 2013-14. The list of projects has been shown at **Annexure-2**.
- 3. Proposed projects for the year 2014-15.

The proposed projects for the year 2014-15 are divided into following three categories-

- (A) Projects already sanctioned during the previous SLSCs.
- (B) Extension of project period up to 2014-15 for the projects sanctioned for the year 2013-14.
- (C) New project proposals.

The committee reviewed the total number of projects and their sanctioned cost for the projects shown in category A and approved the extension of project period for the project shown in category B. The list of projects under category A and B are shown in **Annexure-3** and **Annexure-4** respectively. The list of new project proposals approved along with observation made has been shown in the **Annexure-5**.

After the discussion in the meeting on all the proposals, the over all cost of the approved projects to be implemented during 2014-15, is as given below:-

#### 4. Sub Schemes

The sub schemes of "National Initiatives for Urban Cluster'(NIUS) proposed by Horticulture Department and "National Mission for Protein Supplements" proposed by Fisheries Department has been approved for Rs. 800.00 lakhs and Rs. 562.30 lakhs respectively.

#### 5- Approval of annual plan of Extension Reforms (ATMA).

The committee discussed the annual plan of Extension Reforms (ATMA) and granted its approval.

### 6- Establishment of State Nodel Cell of RKVY in Directorate of and Agriculture Development.

The committee discussed the proposal in the light of provision made in the new RKVY guide line in para 12.1 and appendix D and accorded approval on the condition that concurrence of the Finance Department should be taken before setting up of the State Nodal Cell.

### 7- Discussion on minimum amount of subsidy on various project proposed under RKVY.

It was decided that proposal with an individual subsidy component of less than Rs. 500/- per person should not be taken.

#### Supplementary Agenda:-

The committee has discussed the project proposals brought before the committee in supplementary Agenda. The approval along with observation on such projects has been shown in **Annexure - 6**.

#### OTHER DIRECTIONS GIVEN BY THE COMMITTEE:-

Direction with respect to New Proposals:-

#### 1. Distribution of Pump Sets (Electrical /Diesel) :-

Since there is no comments given by the Agriculture Ministry and this project has been continuously sanctioned since last many years in SLSC, therefore this has been approved with the condition that comments may be obtained from GoI, MoA in the next seven days and resolve objection if any.

#### 2. Project to clear pendency of Sprinkler, pipeline and Drip:-

Since there is no comments given by the Agriculture Ministry and this project has been continuously sanctioned since last many years in SLSC, therefore this has been approved with the condition that comments may be obtained from GoI, MoA in the next seven days and resolve objection if any.

#### 3. Seed Treatment :-

This project is approved with the observations that the crops details and name of the seed treating material used should also be intimated to GoI.

#### 4. Subsidy on Seed Distribution programme:-

The is approved. As per the observation made by GoI, State Govt. will have to indicate crop wise quantity of Breeder Seeds proposed and desired SMR achieved. The seeds need to be of less than 10 years duration.

### 5. Project to Support Tribal having patta rights in forest villages through schemes of Agriculture Department:-

The project is approved. It was suggested by the Joint Secretary, that Impact Evaluation Study through Third Party should be conducted for the project to know the improvement in their financial upliftment.

## 6. Integrated Development of Agriculture in the areas of Primitive Tribes of Saharia, Bega, and Bharia in Sheopur, Dindori, Shivpuri and Chhandwara districts:-

This project is approved. It was suggested by the Joint Secretary that Impact Evaluation Study through Third Party should be conducted for the project to know the improvement in their financial upliftment.

#### 7. Project on Wheat Seed Distribution Subsidy:-

As per the comments received from GoI, since production subsidy is not covered in NFSM, therefore it has been suggested to obtain the comments of Crop Division of GoI, MoA and follow up action taken.

#### 8. Proposal for the Strengthening of Krishi Vigyan Kendras through RKVY:-

Since no comments have been given by GoI, Joint secretary suggested that the comments of ICAR New Delhi should be obtained as per the clause 6.1(g) of RKVY guide lines. Accordingly this project is approved with the condition that the comments from ICAR would be submitted on file to the Chief Secretary for approval.

#### 9. Project to clear pendency of Sub Schemes implemented during 2013-14:-

Joint Secretary has raised his objection for pendency shown in INSIMP (Nutri Cereal) sub scheme as the total allocation and release was given only for Rs. 136.00 lakhs. The Joint Secretary suggested that allocation is available with the ministry under other scheme which should be availed by the department before considering options under RKVY. It was decided that Rs. 9.00 crore be availed under INSIMP and the balance Rs. 0.007 crore is approved from RKVY. The project is approved for the pendency of RADP and Nutri Farm only. The department is also advised to resolve the issue of Nutri Cereal at GoI level.

#### 10. Establishment of Fully Equipped Skill Development Training Centers:-

Project is approved subject to NCVT training programme norms being followed. The Committee also directed such centers at Indore and Ujjain division should also be taken up. The department would identify suitable lands at these districts. These would be part of the sanction the department to include them in this project.

#### 11. Incentive for Establishment of Seed Grading Plant :-

The Committee discussed the project, Joint Secretary has suggested that this project should be submitted first in the Seed Mission for financing and then the remaining part be taken up under RKVY. Committee agreed to his suggestion.

## 12. Project on Assistance to individual for Establishing Custom Hiring Centers: The project is approved subject to adoption of SMAM guide lines.

#### 13. Extension and Maintenance of Pomegranate Cultivation:-

The Committee approved the project with the condition that it should be as per the MIDH norms.

#### 14. Solar Based Micro Irrigation System:-

The Committee approved the project subject to the condition that the DAC norms would be followed.

## 15. Project on Financial Assistance for computerization to MP State Cooperative Seed Federation and its other offices:-

Since there are no comments from GoI, the Joint Secretary suggested that comments of I.T. division may be obtained and accordingly this may be brought before next SLSC for approval. The Committee agreed to his suggestion.

#### 16. Narmada- Kshipra Singhasth Link Micro Minor Irrigation Scheme:-

Since no comments have been received from the GoI, the Joint Secretary suggested that the comments of NMSA division may be obtained and the approval of Chief Secretary be taken on file separately taking into accounts these comments.

#### 17. Project for providing minor Irrigation Facilities by way of Tube Well:-

The project has been discussed at length. Committee has agreed to approve the project.

## 18. Project for Contingent Plan by providing distribution subsidy on Moong/Urd/Hyb.paddy/Hyb.Maize and Hyb.Bajra:-

The Joint Secretary suggested to approve this project on NFSM norms. The Director Agriculture requested that the NFSM has provision of cluster demonstration only and not distribution subsidy on seed varieties of more than 10 years (which are and would not be available in contingent situation), therefore this project should be approved. The committee accepted and approved the project considering contingency due to "Alnino" resulting in probable deficient monsoon.

#### 19. Strengthening of Krishi Gyan Kendras:-

The Committee discussed the project at length. Since this project is being approved by SLSC on a year to year basis and this is the last phase of construction, therefore the committee considered and approved the project with the instruction that attempt should be made to complete the project in this year itself so that the infrastructure is available for various extension activities.
