 action plan involving various interventions for alternate agri / horticultural crops should
 be submitted by the states to DAC&FW.
- For motivating the farmers study tours/ exposure visits and campaigns, if needed, may also be organized highlighting harmful effects of tobacco and long term benefits of alternative crops.
- For implementation and monitoring, contingency expenditure should not exceed 1% of total allocation.
