Sub: Review Meeting to assess the implementation of Rashtriya Krishi Vikas Yojana (RKVY) during 2017-18.

Sir,

It has been decided to convene desk review meetings to assess the implementation of RKVY during 2017-18.

The agenda of the meeting shall be as under:-

1. Discussion on the new changes approved under RKVY as the scheme has now been reoriented as **RKVY- RAFTAAR** for the period of 2017-18 to 2019-20.
2. Review of physical/financial progress of ongoing projects including projects commenced during current year (data to be compiled as per the enclosed format only);
3. Status of utilization of funds and eligibility for release of second installment;
4. Utilization of funds and physical progress in respect of Sub-schemes under RKVY;
5. Reconciliation of Utilization Certificates, Revalidation of unspent balances lying with the States.
6. RDMIS: Updation./completion of database, reconciliation of financial progress as per RDMIS with UCs submitted, issues related to data entry;
7. Submission of next year proposals in DPR format/ status of monitoring of 25% projects.
8. Any other relevant issue.

The meeting will be held from 13th to 17th November 2017 in the Conference Room No.142 at Krishi Bhawan, New Delhi. Schedule of the meetings is attached.


It is requested that Director (Agriculture) and Directors of relevant Departments may be deputed to attend the desk review meeting .
