5) Projects proposed to be taken up during 2015-16 (ongoing programme and new).

1. Ongoing projects

The committee approved implementation of all the ongoing projects during 2015-16 amounting to Rs. 10965.14 lakhs extending time period for projects which could not be completed within prescribed time frame.

2. New projects

A) Establishment of Seed Processing Unit

The project was presented by the Consultant of Goa State Infrastructure Development Corporation Ltd.

Infrastructure like seed processing unit having seed cleaner, gravity separator, elevators, automatic weighing & packing machine, auto control panel, feed hoppers, platform, vegetable seed packing machine, seed testing laboratory and premises for housing machinery & storing of raw & processed seed is proposed in the project.

Chief Secretary opined that the price quoted is very high and needs relook. He enquired whether the rates are calculated based on recent Goa Scheduled Rates. The consultant could not satisfy the query of the committee. Dr. Malik, Additional Commissioner, Government of India stated that the Machinery cost and other cost are as per Government of India norms whereas Civil works cost is too high which needs revision.

After indepth discussion, the committee approved the project in principle and requested to recast /rework the civil cost as per G.S.R and obtain clearance for the recast work from the Secretary (Agriculture) before executing the work.

B) Setting up of an ultra-modern piggery breeding farm at Shigao, Dhat Mollem Goa.

The project presented by consultant appointed by Directorate of Animal Husbandry and Veterinary Services named Ultra Modern Technology "Farm to Table through scientific Pig breeding and slaughtering and meat processing

Good quality exotic stock of Yorkshire, landrace and duroc will be procured and crossed to obtain 2400 piglets annually. Breeding shall be based on artificial insemination or natural boar service semen. Piglets will be weaned every 28 days of age. Sows will be re-bred within 5 days post weaning after they come back to heat. High quality feed will be provided to the animals. Bio security protocols will be followed as per international centres.

Secretary (Panchayatraj) stated that Agonda breed has become a menace. The breeds listed requires lot of feed and utmost care which the department need to take care of. Director ICAR suggested to consult ICAR and farmers of Goa before selecting any breed

Secretary (Finance) and Secretary (WRD) opined that the project will not work in the Government sector. Chief Secretary directed the department to recast the project cost and re-evaluate its efficacy under Goan conditions.

C) Establishment of Training and Demonstration Unit for Hygienic Meat Production and Value Addition in Goa.

The project submitted by CCARI, Goa aims at providing training to educate the meat producers & consumers on hygienic clean meat production through training and demonstration. It is proposed to provide hands on training on value addition of Meat for entrepreneurship and employment generation in Goa by creating training and demonstration facilities at the Institute.

The project involves establishment of Modern Meat Processing Pilot Plant, Meat Processing and Packaging Equipment, Fixtures and Plant Modulations, Poultry Dressing Unit, Packaging material and ingredients for fresh & processed meats etc., Raw material (purchase of live animals etc.), Senior

Research Fellow, Project attendant, Contractual Labors and training component with an total cost of Rs. 101.55 lakhs.

Additional Commissioner, GoI and Secretary(Finance) suggested that the project may be referred to Director General Indian Council of Agricultural Research for comments. Recurring cost, Senior Research Fellow, Project Attendant, Contractual Labour, Packing material may be borne by ICAR. He also opined that the recurring cost and continuation of the project should be taken up by ICAR after the end of the project period. Additional Commissioner suggested that the project duration should be 2 years.

The committee decided to refer the project to DG, ICAR for clarification on the above points.

D) Modification to the project Productivity improvement in Cashew.

Director of Agriculture informed the house that the productivity of coconut needs to be increased along with the cashew crop. He suggested that coconut crop is also proposed to be provided with manures & fertilizers in addition to the cashew crop within the approved project funds. Inputs like Neem Cake, Muriate of potash and Rock Phosphate will be provided for the coconut crop for improvement of productivity in cashew and coconut.

Chief Secretary, Chairman SLSC desired to know the number of farmers benefitted so far under the project. Additional Commissioner stated that the supply of Muriate of Potash may be removed from the inputs proposed.

As the desired information could not be provided on the number of applications received for productivity improvement in Cashew, Chairman advised Director of Agriculture to submit the same to Secretary (Agriculture) for verification.

The proposal for extending the productivity improvement scheme for coconut in addition to cashew, within the approved funds for cashew was approved by the committee
