The Additional Chief Secretary, Agriculture welcomed the participants and after seeking permission of the Chair, formal discussion on the agenda of the meeting was initiated by Director Agriculture and member Secretary of the Committee. The proceedings of the last meeting of SLSC held on 19-06-2014 were confirmed.

Action Taken Report on the Decisions taken in the Meeting of State Level Sanctioning Committee (SLSC) held on 19.06.2014

The Action Taken Report on the decisions taken in the last meeting presented by the Director Agriculture before SLSC. The Committee took note of the Action Taken Report and expressed its satisfaction.

Agenda Item No.3

Review of Funds Utilization

Agenda No. 3.1: During 2011-12

Director Agriculture informed the members of SLSC that during the year 2011-12 an amount of Rs. 17687.20 lakh was released by the Ministry of Agriculture, Govt. of India under Normal RKVY as well as its Sub-Schemes to the State. Out of this, an amount of Rs.17354.45 lakh was utilized and Rs. 332.75 lakh remained as unspent balance. Out of the unspent balance, Rs. 302.75 lakh was surrendered to Govt. of India and Rs.30.00 lakh allocated to Haryana State Seed Certification Agency (HSSCA) for Implementation of Organic Certification of Agriculture Crops and Products in Haryana is still lying unutilized. On the request of ACS, Agriculture SLSC accorded the approval for utilization of the unspent balance of Rs. 30.00 lakh for the year 2011-12 during current year by Haryana State Seed Certification Agency (HSSCA).

Agenda No. 3.2: During 2012-13

During the year 2012-13, an amount of Rs. 17988.00 lakh was released by the Ministry of Agriculture, Govt. of India under Normal RKVY as well as its Sub-Schemes to the State. Out of this an amount of Rs.17862.00 lakh was utilized & Rs. 126.00 lakh left as unspent balance.

Out of unspent balance, an amount of Rs. 100.00 lakh was surrendered to the Ministry of Agriculture, Govt. of India and Rs.26.00 lakh was still pending with Haryana State Seed Certification Agency (HSSCA). SLSC also accorded the approval for utilization of the unspent amount of Rs. 26.00 lakh for the year 2012-13 during the year 2015-16 by HSSCA for setting up of Seed Testing Laboratory.

Agenda No. 3.3: During 2013-14

During the year 2013-14, an amount of Rs. 15929.00 lakh was released by the Ministry of Agriculture, Govt. of India under Normal RKVY as well as its Sub-Schemes to the State. Out of this an amount of Rs.15814.617 lakh was utilized leaving unspent balance of Rs. 114.38300 lakh. SLSC accorded the approval for revalidation of Rs.114.383 lakh and it was desired that the approval from Department of Agriculture and Cooperation, Ministry of Agriculture, Govt. of India may be sought to utilize this amount during this current financial year 2015-16.

Agenda No. 3.4: During 2014-15

During the year 2014-15, an amount of Rs.37203.00 lakh was allocated by the Ministry of Agriculture, Govt. of India under Normal RKVY as well as its Sub-Schemes to the State. An amount for Rs. 25468.00 lakh was released by the Ministry of Agriculture, Govt. of India against which Rs. 15250.039 lakh (i.e. 60%) was utilized by different implementing agencies / departments during the year 2014-15. SLSC accorded the approval for revalidation of an amount of Rs. 10217.96 lakh from Ministry of Agriculture, Govt. of India.

Agenda No. 4: Regularization of implementation of projects taken up during 2014-15

4.1. Agriculture Department

An amount of Rs. 33057.00 lakh was allocated by the Ministry of Agriculture, GOI for Normal RKVY and its Sub-Schemes during the year 2013-14 to the State. Out of this Rs. 15929.00 lakh was released by the Govt. of India as 1st installment. Due to non receipt of 2nd installment of RKVY from the Department of Agriculture and Cooperation, Ministry of Agriculture, Govt. of India, some of the ongoing projects remained incomplete thus leaving a committed liability of Rs.6147.16 lakh which was met out from Rs.18212.00 lakh released as 1st Installment during the year 2014-15.

SLSC accorded ex-post facto sanction for utilizing Rs.6147.16 lakh for completion of the above said projects.

4.1.1. Regularization of project "Additional Fodder Development Prorgamme" under RKVY during 2014-15.

SLSC accorded ex-post-facto-sanction of Rs. 256.00 lakh for this project.

4.1.2 Release of funds under the "Reclamation of alkali soils by applying Gypsum ingredient under RKVY (Stream-I) during the year 2014-15.

SLSC accorded ex-post-facto-sanction for Rs. 329.265 lakh under this project.

4.1.3 Surrendering the Budget of Sub-Scheme "Initiative for Nutritional Security through Intensive Millets Promotion (INSIMP)".

Director, Agriculture informed the House that Rs.442.20 lakh was released by the Ministry of Agriculture, Govt. of India during the year 2011-12 under the Sub-Scheme "Initiative for Nutritional Security through Intensive Millets Promotion (INSIMP)" out of which an amount of Rs.139.45 lakh has been utilized. Further the Scheme was not implemented during subsequent years because Sorghum crop is not grown as food grain in Haryana State. So, an amount of Rs.302.75 lakh was surrendered to the Ministry of Agriculture, Govt. of India vide letter No. 1567/TA-II (RKVY) dated 29.12.2014.

4.2. ANIMAL HUSBANDRY

4.2.1 Transfer of funds from the project namely "Establishment of Indo Israeli Centre of Excellence" to the Project "Outsourcing of Artificial Insemination Services to J.K. Trust through 1145 ILDCs and Release of Rs. 200.00 lakh as committed liability.

Chairman desired to know as how much amount was being spent by the department of Animal Husbandry and Dairying from its own budget under this head. Director General, Animal Husbandry and Dairying informed that in total an amount of Rs. 28.00 crore was spent by the department on Artificial Insemination activity in the State during 2014-15. Chief Secretary desired that a detailed review of Artificial Insemination activities delivered by J.K. Trust needs to be undertaken. SLSC accorded ex-post-facto-sanction for Rs. 200.00 lakh in this project.

4.2.2 Surrendering of Budget of Sub-Scheme "National Mission for Protein Supplements (NMPS)."

Director, Agriculture informed that Rs.830.00 lakh was released by Govt. of India during the year 2012-13 under the Sub-Scheme "National Mission for Protein Supplements (NMPS)." Out of which an amount of Rs.730.00 lakh was utilized. Further the Scheme was not implemented due to lack of approval from Govt. of India for the diversion of fund to special programme for dairy development during 2014-15. Therefore, the unspent balance of Rs.100.00

lakh was also surrendered to Govt. of India vide letter No. 1567/TA-II (RKVY) dated 29.12.2014. SLSC accorded ex-post-facto-sanction for the same.

4.3. Regularization of Projects implemented by Horticulture Department.

Director, Agriculture apprised the Committee that an amount of Rs.600.00 lakh was released under Sub-Scheme "Vegetable Initiative for Urban Cluster (VIUC)" by Ministry of Agriculture, Govt. of India, out of which an amount of Rs.594.31 lakh was utilized with an unspent amount of Rs.5.69 lakh. He also informed that Rs. 362.56 lakh was released against committed liabilities to Horticulture Department for the year 2013-14 from 1st Installment released during 2014-15. Out of this an amount of Rs. 8.23 lakh was also left as an unspent balance. Thereafter, the Horticulture Department utilized the unspent balance for Rs.13.92 lakh (Rs.8.23 lakh under Normal RKVY + Rs.5.69 lakh under Sub-Schemes) in some other projects for the year 2014-15 under Normal RKVY. SLSC accorded ex-post-facto-sanction amounting for Rs. 13.92 lakh under this project.

The following points were also discussed in the meeting.

a) Director, Agriculture informed the Committee that during 2015-16, Ministry of Agriculture, Govt. of India has made an interim allocation of Rs.8476.00 lakh under Normal RKVY (Production Growth + Infrastructure & Assets) and Rs. 4243.30 lakh under Crop Diversification Scheme (Sub-Scheme of RKVY) with a sharing pattern of 50:50 (Centre: State). Therefore, the total interim allocation made by Govt. of India during 2015-16 for the State of Haryana is Rs.12719.30 lakh. The State Govt. has to contribute an amount of Rs. 12719.30 lakh as matching contribution by making provisions in the budget. The total available funds under the new sharing pattern for the current year will be Rs. 25438.60 lakh as per allocation made by Ministry of Agriculture, Govt. of India till date. Smt. Vandana Dwivedi, Addl. Commissioner Govt. of India informed the House that the matter of Sharing Pattern (50:50) of all the schemes has not yet confirmed and the allocation may be revised after confirmation.

- b) Worthy Chairman desired to undertake a review meeting with Addl. Chief Secretary Govt. of Haryana, Agriculture Department and Principal Secretary, Govt. of Haryana, Animal Husbandry regarding the funds utilized by the department as well as allocated to J.K. Trust on Artificial Insemination activity undertaken in the State with full justification and implementation strategies probably within a month.
- c) Chairman advised to convene a meeting shortly with Addl. Chief Secretary to Govt. of Haryana, Agriculture Department and Principal Secretary, Finance Department, Haryana for making provisions in the budget to add on 50% (i.e. Rs.12719.30 lakh) state share as Ministry of Agriculture, Govt. of India already made an interim allocation for Rs.12719.30 lakh under new sharing pattern of 50:50 (Centre:State).
- d) Funds for the Projects approved by SLSC would be released subject to availability of funds and the same shall be utilized strictly in accordance with the Guidelines issued by GOI.
- e) Projects approved by SLSC shall be prioritized and funds will be released by the Nodal Department on merits in consultation with the implementing Departments / Agencies.

f) State Extension Work Plan (SEWP) of Centrally Sponsored Scheme namely "Support to State Extension Programme for Extension Reforms" Agriculture Technology Management Agency (ATMA) of for an amount of Rs. 1696.85 lakh (Rs. Sixteen crore Ninety Six lakh & Eighty Five thousand only) for the year 2015-16 was approved by Chairman of SLSC.
