 Mamata Saxena, Adviser (Horticulture), Department of Agriculture and Cooperation,
 Ministry of Agriculture, Govt. of India was present in the meeting.
- The Principal Secretary (Agriculture), Tripura, the Member-secretary, SLSC has welcomed all the members of the SLSC and initiated the discussion for review of implementation of all projects of 2014-15 and project proposals of 2015-16, with brief overview of the priorities of the State.
- 3. The Director of Agriculture, Tripura has made a presentation indicating the status of implementation of RKVY projects at different sectors during 2014-15, details about the ongoing projects, available project proposals of 103.15 crores for 2015-16 and shortlisted proposals against the interim allocation of Rs. 54.20 crores during 2015-16. Thus the sector wise allocation of Rs. 5420.00 lakhs (as 50:50 Central: State share), as per the project proposals received from Agriculture, Horticulture, ARDD & Fisheries as already screened by the SLPSC in its meeting held on 30th April, 2015 stands like the following:
