MINUTES OF THE STATE LEVEL SANCTIONING COMMITTEE (SLSC) MEETING OF RKVY AND SEWP HELD ON 26TH SEPTEMBER' 2016 AT THE CONFERENCE HALL OF THE CHIEF SECRETARY, ITANAGAR (ARUNACHAL PRADESH)

- 1. The State Level Sanctioning Committee (SLSC) meeting of RKVY Schemes was held on 26th September, 2016 under the Chairmanship of the Chief Secretary, Smti. Shakuntala D. Gamlin, IAS, Govt. of Arunachal Pradesh. The meeting was attended by the member from Agriculture and its allied Sectors and a representative from the Ministry of Agriculture, Cooperation and Farmer's Welfare, Govt. of India to consider and approve the Project Proposals of Agriculture and allied Departments under Normal Rashtriya Krishi Vikash Yojana (RKVY) and additional fund under Agriculture department (Sub-scheme for reclamation of acid soil) and Animal Husbandry, Veterinary & Dairy Development Department (FMD Vaccination Programme) and Fishery Department for (Additional RKVY Fund) for the year 2016-2017 and SEWP (State Extension Work Plan) under NMAET (National Mission on Agriculture Extension Technology). List of the participants shown at Annexure "A".
- 2. While welcoming the members present the Secretary (Agriculture), Govt. of Arunachal Pradesh, apprised the house about the aims and the objective of the SLSC meeting and informed that this SLSC is to approve two important centrally sponsored schemes (CSS) as namely I(A)-Normal scheme of Rastriya Krishi Vikash Yojana (RKVY) and I(B)- Additional fund under RKVY (RKVY sub-scheme) for Agriculture Department for reclamation of acidic soil, FMD vaccination programme under Animal Husbandry, Veterinary & Diary Development Department and Additional fund for Fishery Department. II(A)- The State Extension Work Plan (SEWP) under NMAET (National Mission on Agriculture Extension Technology).
- 3. The Secretary (Agriculture) further asked the Director (Agriculture), Govt. of Arunachal Pradesh to go ahead with the power point presentation on the project proposals under Normal RKVY, Additional RKVY fund and SEWP- 2016-2017 for further discussion.
- 4. Before taking up discussion on Proposals on Normal RKVY and RKVY (Additional fund) and SEWP 2016-2017, Chief Secretary-cum-chairman(SLSC) enquired from the Planning Secretary for the plan proposals of the SLSC which was explained and clarified by the Shri Joram Beda, IAS (Planning Secretary), briefing the gathering further, the Chief Secretary-cum-chairman(SLSC) asked the gathering to identify export potential crop including rice, bring in exotic varieties and explore the potentials of floriculture, and horticultural products for export purposes. She urged the department to make Arunachal rice as export oriented. The representative from the Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India pointed out that India has a very strong and vibrant cooperation with Israel whose experts visit India for demonstration and training in the COEs established under the MoU between the two countries and suggested that the state may like to consider establishing a "Centre for Excellence in Horticulture". Accordingly, Chairperson of the SLSC advised the Department of Horticulture to propose a "Centre for Excellence in Horticulture" in Arunachal Pradesh immediately.
- 5. The proceeding of power point presentation was followed by queries from the Chief Secretary-cum-chairman (SLSC), attending Commissioners, Secretaries, Govt. Of Arunachal Pradesh and comments from the Ministry and approved by the house. The list of approved projects by SLSC under Agriculture and allied department are shown at Annexure-I,II,III,IV,V,VI,VII enclosed.

6. After detailed discussion the following suggestions were made Sector-wise;-

6.1 AGRICULTURE:-

- 6.1.1 <u>OFF-SEASON VEGETABLE PRODUCTION PROGRAMME</u>:- The SLSC suggested for inclusion and introduction of low volume-high value vegetable crops viz. Parsley, Lettuce, Quinoa and Rocket Salad etc in the proposal to be taken up in potential districts of the state.
- 6.1.2 AREA EXPANSION BY LAND TERRACING: Representative of GoI pointed out that in the proposal submitted, no physical target is given, therefore, cannot be supported in lack of details. Moreover, all watershed development measures have been brought under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) already cultivated area - watershed component and therefore, such programme has got to be part of DIP/SIP, and included in the Annual Action Plan of PMKSY for current fiscal year duly approved by SLSC. State may take up the activities under PMKSY after approval of AAP by the SLSC and formulation of detailed DIP/SIP. The SLSC decided to request the Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India to re-consider and review its decision of not-supporting the ongoing "flagship" programme of area expansion by land terracing owing to its immense benefit and popularity among the farmers in adopting settled cultivation instead of the still prevalent primitive method of shifting cultivation. The House observed that, more areas were brought under permanent settled cultivation and increased area under irrigation by adoption of area expansion by land terracing in the state. As previously, Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India had identified this programme as "flagship" programme for the state. The SLSC opined that, the state being a hilly region requires the support of this ongoing proposal for farmers welfare and so did not concur with the suggestion of the Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India to manage it under catchment treatment under PMKSY, as the state does not have large flat land to be managed under catchment treatment and the present proposal is to terraced the land in pockets with food deficit area, therefore, the proposal was approved.
- 6.1.3 The Commissioner (Rural Development), Govt. of Arunachal Pradesh opined and suggested the need for coordination and need to formulate ways and means for convergence of Mahatma Gandhi National Employment Guarantee Scheme (MNREGA) scheme with various agricultural schemes.
- 6.1.4 After a thorough discussion, the SLSC approved rest of the proposal proposed by the Department of Agriculture.
- 6.2 HORTICULTURE: After detailed discussion on the proposals and comments from the Ministry, the members of SLSC have considered the proposals for the approval of the Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India with change of project nomenclature of SL.NO.-(5) under Production Growth for Establishment of 30 Hectares Compact Area High Tech Cultivation of various fruits (In place of large cardamom) at West Siang District to assess the quality & productivity of different variety in farmer's field and SL.NO.-2 under Flexi Programme for Construction of Training Hall-cum-DHO (In place of Conference Hall-cum-DHO) office at Aalo, West Siang District.
- 6.3 **ANIMAL HUSBANDRY, VETERINARY:** The proposed details of dairy units were enquired by Chief Secretary-cum-chairman (SLSC) which was cleared by the department. The attending representative from Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India informed the house **that Mithun is**

a semi wild species. Funds have been released to the state for development and conservation of Mithun under National Programme for Bovine Breeding & Dairy Development. State may not be allowed to take up the project in present form. In place of this state may induct high yielding dairy animals as per the guidelines of dairy entrepreneurship development scheme, and state may resubmit after giving detailed justification. Mrs. Indira Mallo, IAS, Commissioner (Rural Development), Govt. of Arunachal Pradesh explained the importance of Mithun in the Rural Arunachal economy and requested the Representative of Ministry of Agriculture, Cooperation and Farmers Welfare, Govt. of India not to tag Mithun either as wild or semi wild as it is purely domesticated. The house also observed various other importance of the Mithun. The Commissioner (AH,Vety and DD), Govt. of Arunachal Pradesh informed that Mithun rearing is an ongoing programme under RKVY and the beneficiaries are selected from among the BPL families of Mithun Rearing Districts only. As observed by the Ministry, no funds were received under Bovine Development Programme for Mithun rearing in the state. The proposal was approved by the committee with the detail backup letter to follow from the Chief Secretary's desk to the Ministry of Agriculture and farmers Welfare, Govt. of India.

- FISHERY:- The attending representative from Ministry of Agriculture, Cooperation & Farmers Welfare, Govt. of India insisted the proposals under Fishery Department was received separately after other proposals were examined and are yet to be scrutinized by the department. As such it cannot be decided in the present SLSC in absence of expert opinion. Therefore, the proposal of Fishery Department may be taken up separately for approval.
- 6.5 SERICULTURE:- The representative of DAC&FW conveyed the Ministry's view that this item was not covered under MIDH Scheme. Moreover, similar kind of activities are supported through Silk Board, Ministry of Textiles and hence duplication may be avoided. Handicraft Department clarified all the points saying there is no Duplicacy in the proposal and no such funds were received from the Ministry of Agriculture, Cooperation & Farmers Welfare, Govt. of India and all the proposal are for the Govt. Farm of the state. The house observed the genuine need of the proposal and approved all the projects.
- SOIL & WATER CONSERVATION:- The representative of DAC & FW stated that the 6.6 department supports ongoing projects as per decision of the previous SLSC subject to nonduplication of activities and no cost escalation. In respect of new proposals no physical target is given, therefore, cannot be supported for lack of details. All watershed development measures have been brought under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) already cultivated area - watershed component and therefore, such programme has got to be part of DIP/SIP. Further, it should be part of Annual Action Plan of PMKSY for current fiscal year duly approved by SLSC. State may take up the activities under PMKSY after approval of AAP by the SLSC and formulation of detailed DIP/SIP. On queries sought by the Chief Secretary-cum-chairman (SLSC), the Director, Soil & Water Conservation, RWD explained all the activities that are being undertaken under the proposal and he also informed the house that all the proposal are ongoing projects under RKVY fund. The Soil & Water Conservation, RWD is directed to liaise with the Boarder Road Organization (BRO) and Road Construction, Agency to damp the cut out soil in the process of road construction to a particular identified area for conservation of soil and water for productive uses. All the Proposals were approved.
- 6.7 <u>COOPERATION:-</u> The members of the SLSC have considered all the project proposal for approval as all the proposals were ongoing project under RKVY funding.

6.8 In addition to the Normal RKVY proposals as discussed above an additional proposals under RKVY fund and proposal for State Extension Work Plan (SEWP) was also put before the SLSC, which were approved as under:-

(A) AGRICULTURE DEPARTMENT:

- 1) Reclamation of Acidic Soil against sub-scheme of RKVY
- 2) State Extension Work Plan (SEWP) for Sub-Mission on Agriculture Extension-ATMA (SMAE)
- (B) <u>AH, VETERINARY & DIARY DEVELOPMENT DEPARTMENT:</u> Vaccination of FMD Programme
- (C) <u>FISHERY DEPARTMENT:</u> Additional Fund under RKVY

The fund constrain under ATMA programme is being further compounded due to 10% increment in salaries of functionary support engaged under ATMA and to meet the implementation of EPF.
