The committee approved implementation of all the ongoing projects during 2016-17 amounting to Rs. 13933.36 lakhs and extending time period for projects which could not be completed within prescribed time frame.

B. New projects under RKVY for the year 2016-17.

1. Project Name: Upgradation of Sakhar Karkhana

The project submitted by Registrar of Co-op. Societies, Department of Co-operation. Government of Goa is not supported under RKVY as Department of Food and Public Distribution has sugar Development Fund that provides loan to Sugar mills for Modernisation/rehabilitation.

2. <u>Project Name: Upgradation of Government Poultry Farm, Ela Old Goa for dissemination of low input Technology (LIT) Birds among rural Backyard poultry Farmers.</u>

The Project was presented by Dr. Rajaram Naik from Department of Animal Husbandry & Veterinary Services The Project period is for three years with projected expenditure outlay of 372.00 lakhs.

During the discussions Chairman desired to know the higher rates of eggs. Director of A.H. & V.S. informed that these eggs are fertilized eggs and hence fetch higher price over the unfertilized eggs. Additional secretary desired to know whether there is any nutrional difference between the two types. Director CCARI informed that there is no significant nutrional value differences. Additional Secretary expressed that awareness among the consumers and the farmers is required regarding nutritional values of the eggs. He expressed that due to premium rates this project will help in doubling the income of the farmers.

The project is supported under RKVY, however recurring expenditure for the third year is not recommended. The total project has been approved for two years with financial outlay of Rs.253.84 lakhs.

3. <u>Project Name: Study Tour Outside State (Visit to Maharashtra and visit to Kerala)</u>

The Project was presented by Shri Chandresh Haldankar from Department of fisheries. The total project cost was Rs. 3.00 Lakhs.

The project was approved by the committee as per ATMA Norms. The total project cost was restricted to Rs. 1.50 lakhs with ATMA cost norms of Rs. 800/per manday for inter-state exposure visit and Rs. 400/- per manday within the state. The Department may recast the project accordingly

4. Project Name: e-fisheries

The project was proposed by the Department of Fisheries. Director of Fisheries expressed its inability to implement the said project during the current year and informed that some more time is required to study the project implementation. Chairman of the committee accepted the explanation and remarked to study the project more thoroughly and present during next meeting.

5. Project Name: : Improvement of working environment of Agriculture Department

The project was presented by Mr. Saeesh Gandhi from Agriculture department. The total project cost proposed was Rs. 852.00 lakhs.

After much deliberation the project was approved and supported under RKVY to the extend of RKVY guidelines.

C. Modification In The Existing Approved Projects

6. <u>Project Name: E-Krishi for speedy disposal to farmers under RKVY</u>

The project of Directorate of Agriculture was approved in the year 2014-15. The modification for the approved project was presented by Mr. Saeesh Gandhi. The project was presented with revised estimates but within the cost approved by the Satate Level sanctioning Committee. The time frame with one year extension for the project was approved by the State Level Sanctioning Committee. Additional Secretary informed to submit the revised estimate of Rs. 211.25 lakhs to the Department of Agriculture, Cooperation and farmer Welfare, so as to rectify the changes in the project submitted earlier. During the discussion Chairman informed that the States Telangana and Andhra Pradesh has done a similar project and suggested to depute officials to study and if need be the same can be incorporated in the project. The project modifications were approved principally.

7. Project Name: Proposal for strengthening of bunds protecting Khazan Lands under RKVY

The project of Directorate of Agriculture was approved in the year 2014-15. The project by The modification in the project was presented by Shri. Dattaparasad Desai. The project was presented with revised estimates and with additional structures. The revised estimated cost was Rs. 22537.57 lakhs.

Additional Secretary informed to incorporate the project under Prime Minister Krishi Sinachayee Yojana- State Irrigation Plan and In District Irrigation Plan. Additional secretary wanted to know the reasons for rise in the estimated cost to which Director of Agriculture informed that this is due to adoption of new Goa schedule of rates 2015 by PWD. Additional secretary instructed to submit the revised project to Department of agriculture, Cooperation and Farmers Welfare for approval. Regarding change of

names of the various bunds approved by earlier SLSC, Chairman responded that it is not the jurisdiction of the committee and requested (Secretary) Agriculture to look into the matter.

D. Proposal for Evaluation of Rashtriya Krishi Vikas Yojana

The Proposal was presented by NABCONS, a subsidiary of NABARD. Shri. Sushil Naik presented the proposal for evaluating the various projects undertaken since inception of the RKVY in the state at the total cost of Rs. 24.74 lakhs.

Chairman suggested to take up the work under administrative funds.

5. STATE EXTENSION WORK PLAN

b) Approval for State Extension Work Plan (SEWP) of SAMETI Goa.

The details of the various schedule of works to be taken under the ATMA were presented by Mrs. Ana Camara. The State Level Sanctioning Committee set up under Rashtriya Krishi Vikas Yojana is the apex body to approve State Extension Work Plan as per the ATMA guidelines 2014 under National Mission on Agriculture Extension & Technology (NMAET). The work plan is already approved by the Chief Secretary/ Chairman SLEC.

As per the ATMA guidelines SEWP for 2016-17 was placed before the State Level Sanctioning Committee for approval. The proposal was discussed and approved as per ATMA norms.
