**Minutes of the 14th Meeting of the State Level Sanctioning Committee (SLSC)
of National Agriculture Development Programme held on 19.02.2016**

List of participants is annexed.

The Agricultural Production Commissioner and Secretary to Government, Agriculture Department welcomed the Chief Secretary & Chair person of the SLSC and other members to the meeting. He introduced the Government of India representative, Dr.Shakil.P.Ahammed, Joint Secretary, MIDH to the Chief Secretary and other participants. The APC & Secretary to Government informed the Committee that Complete Utilization Certificates have been furnished to Government of India till the year 2014-15 and the committee recorded that. The APC further informed that the entire Gol share of Rs.259.74 crore (out of total allocation of Rs.432.90 crore) has been received for the year 2015-16. The Chief Secretary instructed the APC & Secy to obtain the State share immediately and quicken up the process of implementation of projects. The APC & Secy placed the District Agricultural Plans and State Agriculture Plan before the Committee and informed that after following the due procedures the plans will be furnished to Government of India. The APC & Secy further informed the Committee that the proposals for the year 2016-2017 have emanated from the DAPs and SAP.

The Chief Secretary instructed all the Heads of Departments to evaluate the projects through the Department of Evaluation and Applied research. He also instructed that all the programmes should have focus in terms of area and giving priority to small, marginal, SC, ST & women farmers.

APC & Secy further stated that, for the year 2016-2017, 91 new projects have been proposed for an amount of Rs.778 crore. He added that these projects will be placed in Shelf and taken up whenever the allocation for the year 2016-2017 is made by Government of India. A general instruction was given by the Committee that the funds proposed in the projects for contingencies and consultancy charges should be reworked for all the projects by the Heads of Departments concerned and resubmitted to Tamil Nadu Watershed Development Agency (TAWDEVA).

Project Title	: Integrated Food grain production programme for Paddy
Implementing Department	: Department of Agriculture
Project Cost	: Rs. 16330.00 Lakhs
Remarks of Crops Division	: Component: 1. Incentive for production of less than 10 yrs certified Paddy seeds "Supported as per NFSM norms."
M&T Division of GoI	Component 1. <i>Popularization of Machine Planting (Back ended subsidy) and publicity</i> "Supported Rs.0.04 lakh per hectare only (SMAM norms only)" 2. <i>Subsidy for Tractor</i> "Tractors are not recommended under RKVY" 3. <i>Publicity</i> "For publicity, expenditure may be used from the contingency allowed in RKVY"
Discussion	: There is no production subsidy for HYV paddy seeds under NFSM scheme. In order to motivate the farmers towards cultivating and producing less than 10 years paddy seeds, the subsidy of Rs.8/kg has been proposed under NADP. To compensate loss of seeds upto 20% during machine harvest and processing incurred by the farmers the subsidy proposed is essential. The Publicity components will be reworked and incurred from the admin funds of RKVY. For machine planting, the proposed cost is not only for transplanting of seedlings but also for raising of nursery. Efforts are required for raising of nursery for planting using transplanter. Raised bed nursery/Tray nursery is required for planting by machine for which the amount of Rs.4000/ ha is required and Rs.6000/ha is required for machine planting. Hence total cost of Rs.10,000 per hectare is required for mechanized planting. So the subsidy of 50% i.e., Rs.5000 per ha is essential to popularize the mechanized planting. GOI have approved the tractor component as per SMAM norms under NFSM Rice scheme. Committee accepted and gave directions to the Director of Agriculture to have the focused interventions in terms of area and giving priority to small, marginal, SC, ST & women farmers having landholdings so as to improve the productivity of Paddy.
Resolution	: The SLSC approved the project excluding the tractor component and allowed the adoption of Rs.8 per kg for Incentive for production of less than 10 yrs certified Paddy seeds Rs.5000/- per Ha for Machine Transplanting.

- Crops Division Discussion : Component: Value Addition Training for Millet Growing Farmer @ Rs 20000/No
"Crops Division supports the proposal @ Rs.14,000/- per training in four sessions as per NFSM norms"
- Resolution : There is no production subsidy for less than 10 years high yielding varieties. Hence the production subsidy of Rs.15/kg is proposed. As the RKVY guidelines allow the States to implement new components which are justifiable, the Production subsidy is allowable.
Under NFSM Norms for cropping based training from seed to seed Rs.14000/training in 4 sessions has been fixed. To create awareness among farmers about the nutritional value of Coarse Cereal crop this value addition training is highly essential. Hence for conducting District level training (1 training for each district) Rs.20000/No is proposed.
- Resolution : **SLSC approved the project including the Seed Production Subsidy @ Rs.15000/MT and Value addition training component at Rs. 20000/ Training.**

- Project Cost : Rs. 2976.00 Lakh
- Remarks of Crops Division of Gol : (i)Crops Division supports the proposal for new varieties which are less than 15 years old varieties@ Rs.1000/- per quintal.
(ii) Varieties more than 15 years old may not be brought under seed chain and also distribution of certified seeds. The proposal may be considered, on case to case basis with justification
- Discussion : As the RKVY guidelines allow the States to implement new components which are justifiable, the Production subsidy is allowable.
Rice fallow pulses play an important role in pulses production in Tamil Nadu State by constituting 2.5 L.Ha to 3.00 L.Ha with a production of 1.5 L.MT annually. Relay sowing of pulses is the regular practice followed in these regions i.e. in Thanjavur, Nagai, Tiruvarur, parts of Pudukottai, Trichy districts to avoid the moisture stress as canal irrigation is the only source of irrigation in these areas. Pulses should be grown only by using residual moisture for which only few varieties namely ADT-3, ADT-5 and T9 are unanimously used by all farmers as it yields good using dew and residual moisture and tolerant to Yellow Mosaic Virus.

As these varieties are more than 15 years old, subsidy could not be extended resulting in use of more farm saved seeds and poor yield which in turn affects the state level production. The farmers in the delta districts are also insisting to extend subsidy for more than 15 years old as it equally yields using residual moisture. Hence, considering the huge area and farmers demand, it is requested to approve both the Distribution and Production subsidy at Rs.15/Kg each under NADP in 2016-17.

The Chief Secretary instructed to start the implementation of the pulses programme in the appropriate season. Necessary approval from Government shall be obtained through proper channel. All the programmes focus should be given in terms of area and giving priority to small, marginal, SC, ST & women farmers. Tamil Nadu should become self sufficient in pulses production.

Resolution : SLSC approved the project including the component of extending a production subsidy of Rs.20/Kg for pulses seeds production component for less than 15 year old varieties, Rs.15/Kg for pulses seed production for more than 15 year old varieties and distribution subsidy of Rs.15/kg for more than 15 year old varieties.

Remarks of NRM Division of Gol : The proposal is supported as per guidelines of NMSA. Assistance for pipe, distribution system @ Rs.10000 per hectare is envisaged

Discussion : It was informed that the proposal envisages, conveyance of water to the fields through Gravity flow underground pipeline system eliminating the field channels. No training component is proposed in the project. The proposed support for pipe distribution system under NMSA @ Rs. 10,000 per hectare will not be sufficient. The Command Area Development and Water Management Programme (CAD&WMP) provides Rs.45,000 per hectare for this component. (as per the CAD & WMP interim guidelines issued by MoWR). The sharing pattern between Centre and State is 50:50 (i.e. Rs. 22,500 per hectare each). This cost norm may be adopted. Since, the CAD&WMP is not supporting the small tank ayacuts, the project is proposed under RKVY following the cost norms of CAD & WMP. APC informed that since CAD & WMP is also a Gol programme, the cost norms followed under the scheme may be permitted for the proposal.

Resolution : **The committee resolved that the proposal may be resubmitted to DAC & FW, GOI for consideration with the cost norms of Rs. 45,000/-ha adopted under CAD &WM programme**
