## RKVY State Level Sanctioning Committee (SLSC) Meeting-held on 13 May,2016 under the chairmanship of Chief Secretary Uttarakhand

#### Presence-

Additional Chief Secretary Agriculture Govt. of Uttarakhand extended a warm welcome to the Chairperson, Joint Secretary, (PP) Department of Agriculture, Cooperation & Farmers Welfare GOI, Secretaries of different departments and other members of the Committee and their representatives. Additional Chief Secretary Agriculture mentioned that Govt. of India has allocated Rs. 5236.00 Lakh (Rs 4712.00 lakh centre share & Rs. 524.00 Lakh state share) for the year 2016-17 under normal RKVY. Director Agriculture also mentioned that the projects costing to Rs. 30622.08 lakh are already sanctioned in the last SLSCs held on 04.08.2013, 04.12.2013, 26.08.2014 & 28.01.2015 which also need funding. Additional Chief Secretary Agriculture requested the members of the Committee to discuss on the Agenda points.

# Agenda 1-Confirmation of the proceeding of last SLSC meeting held on 12-08-2015

The minutes of the last SLSC meeting held on 12-08-2015 were confirmed as circulated.

## Agenda 2 - Review of Financial Progress of RKVY

The Status of the releases, expenditure and UCs submitted to the Govt. of India since inception, discussed before the Committee. Additional Chief Secretary Agriculture stated that since inception of the RKVY Rs. 41694.58 lakh has been released (Rs. 41249.58 lakh as Central Share and Rs. 445.00 lakh as State Share) against which Rs. 41198.30 lakh has been utilized till date. The UCs amounting to Rs. 40633.03 lakh has already been submitted to GoI. An amount of Rs. 8070 lakh was released in 2014-15 against which Rs. 8015.56 lakh has been utilized which is 99%. The balance amount of Rs. 54.44 lakh will be utilized by the end of June 2016 and in the year 2015-16 Rs. 4385.56 lakh was released against which Rs. 3970.97 lakh has been utilized which is 91 %. The balance amount Rs. 414.59 lakh will be utilized end of June 2016. UCs thereof will be submitted by the end of June, 2016.

a- Strengthening of state fertilizer quality control laboratory Rs. 30.00 lakh and

b- Strengthening of state pesticide quality control laboratory, Rudrapur Rs. 6.00 lakh.

The Committee after discussion agreed to approve all the above projects as per norms the total amount Rs. 865.67 lakh.

## Agenda4- Project Proposed for Funding in 2016-17 Against Interim Allocation (Normal RKVY)

Director Agriculture mentioned before committee that 24 projects earmarked and approved by SLPSC for the release of funds during 2016-17. The meeting agenda notes were sent to GoI and GoI gave views/suggestions on few of the project which was discussed in the SLSC meeting.

On UOCB Project" Support for Service Providers and Supply Chain Facilitators at Cluster for Organic Production and Marketing" GoI letter no.-612/RKVY/43/2015-16, Dated 27-04-2016 gave view/ suggestion that for the concerned project only 25% assistance can be provided.

The committee approved that the project will be implemented as 25% assistance.

2- (A)- On Dairy Development project "Renovation of the Dehradun dugdh sangh dairy plant" GoI gave views that the department should provide the complete work list/areas of concern of project/ works to be done under project in 2016-17 along with physical & financial progress. It was decided in the meeting that the DPR of the project will be made by NDDB. The details regarding land availability along with DPR should be put up in next SLSC. In SLSC a total amount of Rs. 10.00 lakh was approved for the project for 2016-17 for miscellaneous expenses.

(B)- On other projects of Dairy Department viz. "Modernization of milk cooperative societies in Nainital & U.S Nagar, Strengthening of dairy infrastructure at Haridwar Dugdh Utpadak Sahakari Sangh Ltd (Shikarpur) Haridwar" & "Strengthening of dairy infrastructure at cooperative milk producer unions of Dairy Department GoI desired the physical & financial progress with respect to the amount released till date.

The matter was discussed in the meeting. The representative of Dairy Department informed that the physical & financial progress of every project has been updated on RKVY, RDMIS & also explained about the details of works already done in the project before the committee.

After the discussion funds for these project were approved.

(C) Regarding the project construction of over head RCC water reservoir and SMP godown at Nainital DUSS ltd., Lalkua, Nainital. The representative of dairy deptt. informed that the project has been sanctioned in last SLSC and DPR has already been made available to the nodal deptt, which is confirmed by the nodal department.

#### After discussion funds for these project was approved.

On ULDB Project Proposal for "Establishment of Automatic Compact fodder block Shyampur, Rishikesh and Rudrapur, U.S.Nagar" GoI gave views that the department should provide the complete work list/areas of concern of project/ works to be done under project in 2016-17 along with physical & Financial progress. The representative of ULDB informed that the physical & financial progress of the project has been updated on RKVY, RDMIS. He also informed the committee regarding the component wise physical & financial progress of work done. He informed the committee that the Rs. 610.52 lakh has been spent and civil work has been completed in Rudrapur and Shyampur. The order is placed for Errection and commissioning of automatic compact fodder block plant machinery on turnkey basis at both sites for which Rs. 240.00 lakh is required.

#### The committee approved the funds for 2016-17 as presented.

- 4- Committee did not approve the release of fund Strengthening & modernization of chawki rearing centers (CRC's) and cocoon markets of Silk Department because GoI commented that the scheme/Project with same objectives is also being run by department of Horticulture central Silk Board and if a scheme with same objective is also approved under RKVY then there will be duplicity of work.
- 5- In the project for "Protection of Agriculture Land & Crops from Wild Animals in Uttarakahnd" of Department of Agriculture GoI commented that this project may be implemented on 25% assistance. This Matter was discussed in the meeting & Director of Agriculture informed that this was an ongoing project and was already sanctioned in the SLSC meeting dated 28.01.2015. The Project is being implemented on the norms of IWMP & NRM which 90 to 95 percent assistance in community land and about Rs. 1100.00 lakh has been already utilized.

The committee after discussions approved the release of fund for project 2016-17 with condition that before releasing the money comments from RKVY Cell of Govt. of India will be again taken for 92 to 95 % assistance by giving full facts.

6- Regarding Horticulture Department Project "Promotion of flower production in Uttarakhand" Joint Secretary GoI. gave direction that for the concerned project only 25% assistance can be provided. Committee gave suggestion to implementing agency to change the project with 25% subsidy assistance. The committee approved that the project be implemented as 25% assistance.

7- Regarding the project "Seed distribution of vegetables and spices to farmers of Uttarakhand" the committee approved the allocation of Rs. 100.00 lakhs for 2016-17 on 50% assistance, since it is an ongoing project and Rs. 139.50 lakh has already been utilized.

## Agenda 5-Revised Cost and Physical Target for Approval

A. Change of project area within Garhwal Division under "Integrated Farming system based on Multipurpose Water Harvesting Garhwal Mandal (Agriculture Deptt.)" Director Agriculture told the committee that the project on "Integrated Farming system based on Multipurpose Water Harvesting Garhwal Region was sanctioned in 2011-12 and is being implemented in the Garhwal Mandal. The District Pauri of the region has large area as compared to other districts. So there is a greater demand of water harvesting structures in district Pauri due to large rain fed/un irrigated area while in district Uttarkashi, Dehradun & Rudraprayag, there is a saving of Rs. 190.00 lakh in the sanctioned amount of the project so it was proposed to transfer the above saving of Rs. 190.00 lacs to district Pauri for water harvesting without affecting the overall sanctioned amount of the project.

The proposed was appropried of the project.

The proposal was approved after discussions by the committee.

- B. The proposal for inclusion of Farm Machinery Banks in the project on "promotion of farm mechanization" was discussed in detail and after discussions it was decided that the detailed work plan and the significance of farm machinery bank be prepared and put up in next SLSC meeting after getting due approval of SLPSC.
- C. "Integrated project of agriculture & soil conservation" is already sanctioned & being implemented by deptt, of Agriculture. The Director Agriculture informed that the District Chamoli which was already included in the project in past but due to some typing mistake the district was left out from the minutes of the SLSC dated 28.01.2015. The farmers of the district Chamoli are demanding the implementation of the project in the district. After discussions the committee approved the inclusion of district chamoli in the already approved project without affecting the sanctioned amount.

After discussion committee approved the correction as presented.

Support to State Extension Programme for Extension Reforms-ATMA Under Sub-Mission on Agricultural Extension (SMAE) & National Mission on Agricultural Extension and Technology (NMAET) (2016-17)

Director Agriculture mentioned that the proposed projects are already supported by GoI. The committee requested to give approval to State extension work plan of Support to State Extension Programme for Extension Reforms under NMAET for the year 2016-17 amounting to Rs. 1132.56 Lakh as per details given below;
