Director of Agriculture cum Member Secretary (SLSC) Himachal Pradesh, Shimla-5 MINUTES OF THE MEETING OF STATE LEVEL SANCTIONING COMMITTEE (SLSC) UNDER RASHTRIYA KRISHI VIKAS YOJANA (RKVY) HELD UNDER THE CHAIRMANSHIP OF SH. V.C. PHARKA, CHIEF SECRETARY, GOVT. OF HIMACHAL PRADESH ON 18TH JULY, 2017 AT 4:00 PM.

The list of participants is enclosed at Annexure-I.

The Additional Chief Secretary (Agri.) to the Govt. of Himachal Pradesh welcomed the Chairman, representative of Govt. of India and other members of State Level Sanctioning Committee (SLSC). He informed that Govt. of India has conveyed an allocation of ₹22.94 Crore in favour of Himachal Pradesh as 90% Central Share under RKVY for the year 2017-18. However, the total funds to the tune of ₹25.50 Crore would be available for current financial year on 90:10 sharing basis.

He also apprised that the allocation for the current financial year is low and the said matter has already been taken up with the Secretary, Department of Agriculture Cooperation & Farmers Welfare, Govt. of India. He also emphasised that the projects placed before the SLSC for approval may be prioritized by different stakeholders keeping in view the low allocation.

Item No. 2: Project Proposals for the year 2017-18:

The members of SLSC were informed that the meeting of State Level Project Screening Committee (SLPSC) was held on 7th June, 2017 in which different stakeholder departments presented their project proposals. All the stakeholder departments were requested to re-submit the revised project proposals keeping in view the guidelines/observations of the Screening Committee. Accordingly, the revised project proposals submitted by different stakeholders were sent to the Govt. of India and NITI Aayog through courier as well as e-mail. Thereafter, the pre-SLSC meeting was convened at Govt. of India level on 14th July, 2017 which was also attended by representatives of all the stakeholder departments of Himachal Pradesh.

It was further informed that in this meeting 33 projects worth ₹7365.024 lakh (16 projects worth ₹2306.272 lakh under Production Growth & 17 projects worth ₹5058.752 lakh under Infrastructure & Assets stream) would be



presented by different stakeholders for approval. Thereafter, sectoral presentation of projects proposed for sanction/approval for 2017-18 was made as under:

Fisheries:

The representative of Fisheries Department presented 6 project proposals worth ₹519.50 lakh (2 projects worth ₹46.10 lakh under Production Growth and 4 projects worth ₹473.40 lakh under Infrastructure & Assets stream) as per list given in Annexure-II. After detailed deliberations, the Committee approved all the projects costing ₹519.50 lakh.

Animal Husbandry:

The Director of Animal Husbandry presented 10 projects worth ₹2000.03 lakh (6 projects worth ₹889.470 lakh under Production Growth and 4 projects worth ₹1110.56 lakh under Infrastructure & Assets stream). Out of 10 projects, 4 projects viz., 1) "Providing Veterinary Medicines and Equipments to Veterinary Dispensaries opened under Mukhyamantri Arogya Pashudhan Yojna", 2) "Proposal for Foot & Mouth Disease (FMD) Control in Himalayan State, Himachal Pradesh", 3) "Strengthening of Poultry Sector in Himachal Pradesh" and 4) "Strengthening of Milk Processing Plants, Increasing Farm Income and Skill Building" have not been approved by the SLSC as these projects were not supported by the Govt. of India.

In all, six projects amounting to ₹1207.52 lakh (i.e. 4 projects under Production Growth amounting to ₹709.52 lakh & 2 projects under Infrastructure & Assets worth ₹498.00 lakh) were approved in respect of Animal Husbandry sector.

Horticulture:

The representative of Horticulture Department presented 12 project proposals amounting to ₹1599.634 lakh (7 projects worth ₹770.702 lakh under Production Growth and 5 projects worth ₹828.932 lakh under Infrastructure & Assets stream). The Chairman pointed out that since ample funds are available with the Department of Horticulture under World Bank assisted Horticulture Development Project and MIDH, therefore, the activities which are already covered in the said projects are not be supported for funding under RKVY. Since, the project titled "Establishment of Climate Smart Model Village in Himachal Pradesh" was multi year & the new RKVY guidelines shall be applicable from next year i.e. 2018-19, therefore, this



project was approved for one year only. The TA/DA & Institutional Charges proposed in the said project are also not allowed. After comprehensive discussions, 7 projects amounting to ₹636.15 lakh (i.e. 4 projects under Production Growth amounting to ₹446.85 lakh & 3 projects under Infrastructure & Assets worth ₹189.30 lakh) were approved.

Agriculture:

The Department of Agriculture presented 5 project proposals amounting to ₹3245.86 lakh (1 project worth ₹600.00 lakh under Production Growth and 4 projects worth ₹2645.86 lakh under Infrastructure & Assets stream), the list of which is given at Annexure-II. The project titled "Diversified Agriculture through Vegetable Cultivation" amounting to ₹600.00 lakh was prepared as per Govt. of India norms and supported by them. The SLSC approved the project as such keeping in view the significance of the project in doubling the farmers' income.

While having discussion on the project titled "Promotion of Vermi Composting & Organic Farming", the representative of the department apprised the Committee that the said project has been formulated as per the budget assurance of the State Govt. and the project has been duly supported by Govt. of India. The Principal Secretary (Hort.) to the Govt. of H.P. was also of the view that the Vermi Compost is vital in organic farming/sustainable agriculture. Finally, the project was approved. The project on "Promotion of Farm Mechanization amongst Hill Farmers" duly supported by GOI was approved as such owing to its importance in reduction in drudgery & labour cost besides immediate benefits to the farming families.

During the course of discussion on the project titled "Community Minor-Irrigation Schemes" the representative of the department informed that 97 Communities Minor-Irrigation Schemes having CCA of 1138.30 ha. have been proposed under this project and about 1256 farming families would be benefited. The project has also been supported by the Govt. of India. After comprehensive deliberations & keeping in view the importance of irrigation in doubling/increasing the farmers' income, the project was approved. Since the project titled "Strengthening of Agricultural Infrastructure" was an ongoing project and supported by the Govt. of India, therefore, the project was also approved as such. In nutshell, the Committee approved all the

projects worth ₹3245.86 lakh (i.e. 1 project worth ₹600.00 lakh under Production Growth and 4 projects worth ₹2645.86 lakh under Infrastructure & Assets stream).

In all, 33 projects worth ₹7365.024 lakh were posed out of which 24 projects worth ₹5609.03 lakh (11 projects worth ₹1802.47 lakh under Production Growth & 13 projects worth ₹3806.56 lakh under Infrastructure & Assets stream) were approved by the SLSC as per detail given on Annexure-II. However, the allocation of funds was restricted to ₹2550.00 (₹2294.00 lakh as Central Share & ₹256.00 lakh as State Share) lakh as per allocation received from GOI. The SLSC authorized the Chairman to make fund allocation against approved projects depending upon the availability of funds under the scheme. However, allocation of balance amount shall depend upon the additional allocation, if any received from GOI. The Committee also accorded its approval to use administrative cost of 1% by Nodal Department as per the guidelines of RKVY.
