Minutes of the meeting of State Level Sanctioning Committee (SLSC) held on 29.05.2017 under the Chairmanship of worthy Chief Secretary Sh. D.S. Dhesi, IAS for the approval of Annual Action Plan (2017-18) of Rashtriya Krishi Vikas Yojana (RKVY).

A meeting was held on today i.e. 29.05.2017 on the subject cited above. The list of officers who attended the meeting is annexed at **Annexure X**.

At the outset, Principal Secretary to Govt. of Haryana, Agriculture and Farmers Welfare Department welcomed the Chairman and other members of the State Level Sanctioning Committee and apprised them about the background and salient features of the Centrally Sponsored Scheme (60: 40, Centre: State) the Rashtriya Krishi Vikas Yojana (RKVY). He said that RKVY was launched in the year 2007-08 with an aim to increase the annual growth rate of agriculture and allied sectors by boosting public investment. RKVY is an additional Central assistance to the State Plan in agriculture and is a project specific scheme. He further said that RKVY funds are provided to the State as 100% grant of Central Government in the following streams:

- (i) RKVY (Production Growth) with 35% of annual outlay.
- (ii) RKVY (Infrastructure and Assets) with 35% of annual outlay;
- (iii) RKVY (Special Schemes) with 20% of annual outlay; and
- (iv) RKVY (Flexi Fund) with 10% of annual outlay (States can undertake either Production Growth or Infrastructure & Assets projects with this allocation depending upon State specific needs / priorities).

The Director, Agriculture and Farmers Welfare mentioned that the Department of Agriculture and Farmers Welfare, being the Nodal Department for RKVY invited project proposals from all stakeholder Departments and the projects were scrutinised and further finalised by the State Level Project Screening Committee (SLPSC) in the meeting held on dated 19.04.2017. Again after receiving the agenda of the Annual Action Plan RKVY – 2017-18, the Ministry of Agriculture and Cooperation, GoI held a pre-SLSC Meeting on 24.05.2017 to scrutinize the project proposals as per RKVY Guidelines which was attended by the representatives of the all the stakeholder Departments of the State Government.

Thereafter, the Director, A&FW –cum– Member Secretary, SLSC gave a Power Point Presentation on the Agenda Items related to the Annual Action Plan 2017-18 of RKVY.

After due deliberation, the following decisions on agenda item-wise were taken:

Agenda Item 1.

Confirmation of Proceedings of the Meeting of State level Sanctioning Committee (SLSC) held on 01.07.2016.

The Proceedings of the last meeting of State level Sanctioning Committee (SLSC) held on 01.07.2016 were confirmed.

Agenda Item 2.

REVIEW OF FUNDS UTILIZATION (2014-15, 2015-16, 2016-17)

The Director, A&FW presented the following figures on fund utilization in the last three years as mentioned above as under:

The Additional Chief Secretary, Finance pointed out the issue of low expenditure in the year 2016-17 (50.43%) and the Chairman, SLSC wanted to know the reasons for the low utilization of funds during the year 2016-17. The Director, A&FW clarified that there is an unspent balance of Rs. 97.86 Crores for the year 2016-17 which could not be utilized because of the following reasons:

(i) The major share of unspent funds (Rs.80.66 Crores) lies with the Agriculture Department as it could not finalize the list of beneficiaries identified through inviting On-line applications for disbursal of subsidy under DBT under various schemes before 31.03.2017. However, the beneficiaries list is ready now for disbursal of subsidy for which the revalidation of the unspent fund is required and proposal in this regard is being sent to GoI. Once the revalidation is approved, the funds will be immediately disbursed as the bills of the same are ready.

SLSC approved the proposal of revalidation of unspent funds to the tune of Rs. 97.86 Crores (2016-17) so that the same can be utilized in the year 2017-18. The Chairman SLSC advised all the stakeholder Departments to immediately take up preparatory work and utilize the unspent funds once the revalidation approval is received.

Agenda Item 3.

Department wise progress made during the year 2016-17

The worthy Chairman reviewed the progress of Department wise projects that were undertaken during the year 2016-17 and advised to expedite the projects as soon as the unspent amount is revalidated from GoI. He further advised that the timeline of RKVY projects approval may be worked out in such a manner that by the first week of April the Annual Action Plan may be got approved by SLPC and the same may be submitted to GoI for release of the first installment (50%) under RKVY. Accordingly the Department of Agriculture and Farmers Welfare may hold meeting with all stakeholder Departments and invite project proposals as early as possible and the same may be scrutinized and finalized by the State Level Project Screening Committee (SLPSC) by end of February.

Agenda Item 4.

ANNUAL ACTION PLAN OF RKVY (2017-18)

The Director, A&FW presented before SLSC the Annual Action Plan of self of projects to be undertaken by the stakeholder Departments for the year 2017-18. He further mentioned that the allocation made by GoI under RKVY for the

year 2017-18 is Rs. 18351.66 lakhs. As per the Guidelines the SLSC can approve projects up to 150% of the state allocation under RKVY for funding in a year. Therefore, there is a need to scrutinize and prioritize the projects proposals received from various Departments which has already been done by the State Level Project Screening Committee (SLPSC).

Under the RKVY Sub-scheme, the allocation received from GoI for Crop Diversification Programme in the State of Haryana to the tune of Rs. 1258.00 Lakhs was approved and confirmed by SLSC.

On the overall implementation of the CSS – RKVY the following decisions were taken:

- i. That effort should be made by all the Departments to get the timely sanction and release of funds from GoI and State Government.
- ii. That the first installment (50%) may be got released from GoI to speed up the execution of projects under RKVY.
- iii. That the concerned Departments should immediately start pre-project activity and preparatory field work notwithstanding the status of release of funds from GoI and State Finance Department.
- iv. That Departments should ensure that utilization certificate be sent to GoI in time for claiming further installment of funds.
- v. That the Forest Department may coordinate with Agriculture Department and CCS HAU Hisar for preparation of detailed project proposal on Agro-forestry and allied sectors.
- vi. That the peri urban farming projects proposal with physical/financial details submitted by M.D, HSHDA in the SLSC be taken up with RKVY division of Ministry of Agriculture and Farmers' Welfare and Cooperation, GoI.
- vii. That fortnightly review meeting may be held to monitor the progress of projects at the end of Principal Secretary of Agriculture followed by of SLSC Meeting in August, 2017.
