Present Issues:

- **Cattle Breed Improvement Project for establishment of Integrated Livestock Development Centers (ILDC-64) , Project Year- 2013-14(Duration 5 Years)**

An Amount of Rs 896.31 lakh towards project cost was released between 2013-14 to 2018-19 to establish 64 ILDC in 3 districts (Cuttack-36, Dhenkanal-14, and Nayagarh-14) & to take up Organized Breeding programme in cattle and buffaloes. The Project was to be completed by 31.03.2019. However, as per the agreement made with JKTGVY, it will be

completed during August'2019. Permission may be accorded for extension of the project up to August 2019.

- **Request to permit for inter componential change in allotted budget- NRRI**

ICAR-NRRI was sanctioned an amount of Rs. 432.4 lakh under the project "IT -Enabled Self Sufficient Seed System for Rice (4S4R)". For seed go-downs constructions for FPCs costs Rs. 40-50 lakh. However, provision was only made for Rs. 8 lakhs per go-downs. Presently, NRRI has reported that Rs.200-205 lakh is savings from different components. Therefore, They have requested to permit for inter componential change so that the savings could be utilized. Permission may be accorded for inter componential change in the project.
