Minutes of the 17th Meeting of the State Level Sanctioning Committee (SLSC) of Rashtriya Krishi Vikas Yojana/ National Agriculture Development Programme held on 29.01.2019.

List of participants is annexed.

At the outset, the Agricultural Production Commissioner and Principal Secretary to Government, Agriculture Department welcomed the Chief Secretary & Chair person of the SLSC, Additional Chief Secretary, Finance Department and other members to the meeting. He introduced the Government of India representative. Shri.P.K.Swain. Joint Secretary, Marketing Division and nodal officer for Tamil Nadu and Shri. Vijaya Rajmohan, Director, Trade, Ministry of Agriculture to the Chief Secretary and other participants. The APC & Principal Secretary to Government gave an overall view about RKVY-RAFTAAR implementation in the State. He informed the Committee that the allocation during 2018-19 is Rs.275.33 crore and an additional allocation of Rs.100 crore is expected. The APC & PS said that considering the total allocation to be Rs.375 crore for the year 2018-19, the projects for the year 2019-20 shall be approved as per the RKVY guidelines for Rs.562 crore which is 150% of the allocation of 2018-19. Though the total outlay proposed is Rs.746 crore, the remaining projects will be kept under shelf of projects to be taken up if additional allocation is received. The APC & PS explained how the prioritization of projects has been done in consultation with the Principal Secretary. Animal Husbandry, Dairying and Fisheries and the Heads of other NADP implementing departments. He explained how a colour coding of Green for Priority projects and Blue for non-priority projects has been given in the Power point presentation. The APC & PS informed the Committee that ICAR-Sugarcane Breeding Institute and Department of Sugar have been included as implementing departments as they have proposed one project each during 2019-20. The representative of DAC & FW Gol stated that RKVY division has already forwarded their detailed comments on each item of the proposal subject to the stipulation made by the RKVY division therein.

Discussion:

The Agricultural Production Commissioner and Principal Secretary (APC & PS) to Government informed the Committee that the progress shown in the presentation is based on the latest report given by the departments and explained that Tamil Nadu has received both the installments from Government of India as per the allocation and additional funds

for the year 2018-19 are expected shortly. He pointed out that the overall financial achievement is 70%. The Chief Secretary reviewed the performance department wise and requested the Head of the Departments to give the probable date of completion. With 75% financial achievement, the Director of Agriculture replied that all the projects will be completed by March 2019 and the Construction of Integrated Agricultural Extension Centre project will be completed by June 2019. The Vice Chancellor, TNAU informed that action is being taken to complete the projects by March 2019.

The APC & PS informed the Committee that joint review meetings are conducted by the Principal Secretaries of Agriculture and the Animal Husbandry, Dairying & Fisheries Departments apart from convening of independent review of progress of NADP projects. The Principal Secretary, Animal Husbandry stated that the issues pertaining to some infrastructure projects of Departments and Universities under his fold have been sorted out and the projects are expected to be completed by the end of the financial year. The Chief Secretary pointed out that as the Country is going into elections in 2 months, the tenders have to be finalized within 10 to 15 days to fructify by March 2019. The Director of Animal Husbandry informed that tenders are yet to be floated by Tamil Nadu Medical Sciences Corporation in respect of two projects. The Additional Chief Secretary (ACS), Finance Department suggested that short tenders may be floated if needed. The CS suggested analyzing the Government e-Market Place (GeM) prices to peg mark what the actual price is. The Principal Secretary, Animal Husbandry, Dairying & Fisheries assured that a couple of meetings will be held with other procuring agencies to finalize the procurement process.

With respect to Dairy Development, it was informed that the tender processes are delayed for want of Special Officers in the Dairy Unions and Tamil Nadu Cooperative Milk Producers' Federation Limited (TCMPF) in the absence of elected representatives. The Additional Chief Secretary, Finance remarked that there will be some default mechanism in existence for such occasions and requested to go for the same. The ACS, Finance finally suggested going for tenders by the executive authority and get the action ratified once the elected representatives assume charge. The Director of Fisheries informed that tender process has been completed for all the six projects and that they are expected to be completed by March 2019. The Vice Chancellor, Tamil Nadu Veterinary and Animal Sciences University (TANUVAS) assured that all the projects will be completed by March 2019 as 80% of the expenditure is already made. Responding to the 0% financial achievement pointed out by the APC & PS, the Construction Engineer, Tamil Nadu Civil Supplies Corporation (TNCSC) informed that tenders have been finalized for the project and Agency has been fixed for fabricating the Portable paddy covered sheds for open plinth cap storage of paddy. He further assured that the project will be completed by March 2019.

The Chief Secretary (CS) enquired about the slow progress of Public Works Department (PWD) projects and the Chief Engineer, PWD responded by saying that the works are under way and they will be completed by March 2019. It was explained that for the project with 8 works at a total outlay of Rs.21 crore, so far Rs.12.50 crore alone has been released in three years with Rs.2.5 crore more expected as second installment for the year 2018-19. It was also informed that no additional projects will be sanctioned in the year 2019-20 if the existing project is delayed further.

The CS requested all the HoDs to expedite the implementation.

Agenda IV

Project Proposals for the Year 2019-20

The APC & PS stated that for the year 2019-20, projects have been proposed for an amount of Rs.746.764 crore to accommodate more projects and take them up on priority basis based on the final allocation. The APC & PS informed that Committee that a Pre scrutiny meeting was held at the Government of India level on 22.01.2019 at Krishi Bhawan and the remarks of the divisions of Ministry of Agriculture, Government of India have been communicated for each project. The Joint Secretary, Marketing, Government of India (GOI) informed the Committee that the comments of subject matter divisions of Gol should be taken care of. The Joint Secretary, Marketing, Gol further informed that final comments are pending from Government of India for most of the Animal Husbandry and Dairy Development projects. The APC & PS responded by saying that the HoDs have revised or modified the components/ projects based on the comments of Gol. The APC & PS explained that GoI have indicated that all the projects which do not fit into any of the existing Centrally Sponsored Scheme (CSS)/State schemes for cost norms, a certificate of reasonableness for the cost norms must be given by then State Level Project Screening Committee (SLPSC). Also, for all the projects, details of locations and location wise physical & financial targets need to be furnished to Government of India. The Gol have commented that geo tagging needs to be done for all the infrastructure & Assets projects. Detailed Estimate and drawing need to be furnished to all the infrastructure projects. The APC & PS explained that weightage for the implementing departments are given based on the fund support that they receive from various schemes of Central and State Governments other than RKVY. The departments like Horticulture and Fisheries which receive substantial funds from Government of India schemes like Mission for Integrated Development of Horticulture and Blue Revolution are given lower allocation under RKVY and departments like Agriculture and Animal Husbandry are given higher allocation. The APC & PS presented the overall budget abstract for the year 2019-20 and as requested, the Heads of implementing departments presented their projects before the Committee.

The APC & PS informed that seed coconuts have already been procured by the Director of Agriculture & Director of Horticulture & Plantation Crops.

The CS suggested taking the two newly posted Assistant Project Directors (APDs) in Delta Districts on board with regard to the implementation of Gaja Cyclone Livelihood Package and the APC & PS assured to include them in the process.

Discussion

The ACS, Finance gave an outline of the Integrated Farming System (IFS) project being implemented on pilot basis during the year 2018-19 for the notice of the Gol representatives. He expressed his belief that IFS and Collective farming projects implemented in the State have the potential to make the Gol mandate of *Doubling the farmers Income* a reality. The various models - Dry land, Wetland and Garden land models of IFS and their components were explained in detail by the Director of Agriculture. The APC & PS highlighted the crucial role played by the officials of Animal Husbandry and Fisheries department in implementing IFS. The ACS, Finance requested the APC & PS to make a presentation on the implementation of IFS at Government of India level. The ACS, Finance further suggested bench marking the original income and lifestyle of farmers and assessing the impact after the implementation of IFS. The ACS, Finance opined that shade nets and poly houses of small sizes of 20-30 cents also should be included. The JS, Marketing, Gol requested some success stories and short films on the IFS project. The CS suggested for including

one of the blocks in Gaia Cyclone affected areas under IFS. The Commissioner of Agricultural Marketing suggested inclusion of Commercial tree crops in the models and the ACS, Finance remarked that as per the suitability of the area, water availability and priority of the farmers any component can be included. The CS suggested going for Commercial trees in the borders and bunds.

Resolution: The SLSC resolved to approve the project for Rs.51.2725 crore with a remark that commercial trees also should be included in the silviculture component wherever required.

Discussion

The ACS, Finance enquired about the need for taking up so many Integrated Agricultural Extension Centres (IAECs). The Director of Agriculture informed that out of the 385 blocks available in the State, 146 blocks have been provided with IAECs (100 under NABARD and 46 under NADP) and 9 more IAECs are under progress under NADP 2018-19. The APC & PS explained in detail about how the IAECs are helpful

for the farmers to get advisories and inputs of Agriculture, Horticulture, Agricultural Engineering, Marketing and Seed Certification under one roof. He further informed that the places where the existing buildings are dilapidated are taken up on priority and the buildings are demolished to construct a new IAEC in that place.

The ACS. Finance advised that innovative projects must be mooted by the Agriculture Department. He urged the officials to envision taking the Bio-fertilizer production to block level by involving the FPOs to put up such units by sourcing the culture material from the Universities and Krishi Vigyan Kendras (KVKs). The ACS, Finance expressed his belief that the block level Bio-fertilizer production will pave way for adequate availability thus reducing chemical fertilizer consumption. He further suggested introducing production of seedlings of hybrids and supplying to farmers which will reduce the duration in main field by one month. Initially, such small production units should be established in Government Farms and then private ventures in this regard should be encouraged and supported.

The SLSC resolved to approve the project for Rs.106.00 Crore and to decide upon the number of IAECs to be taken up based on the allocation and constructed as per State PWD norms.

General Suggestions:

The Director, Trade, Government of India put forth some general suggestions before the Committee to be considered by the concerned Departments.

- i) Dendrobium orchid has a huge potential in the State owing to suitable climatic condition. At present, these orchids are imported from Thailand. If a Tissue Culture laboratory is set up to produce the planting material of these orchids, there is a lot of scope for Tamil Nadu to emerge as a leader in the country.
- ii) For most of the horticultural crops like Grapes, Pomegranate etc., the germplasm are imported from abroad with the assistance of APEDA. The CS pointed out that in the absence of a regional or sub office of APEDA in the State, the schemes of APEDA are not largely taken up. The APC & PS pointed out that a letter in this regard has been sent to the Commerce Ministry at Government of India and the result is still awaited. The Director, Trade assured that the Trade Policy Division will recommend the same to Commerce Ministry in the wake of prominence being given for the New Agricultural Trade Policy. The ACS, Finance remarked that the local fruits like Guava and Banana should be promoted. The CS opined that there is lot of scope to promote suitable fruits in the Ghat areas due to the destruction of Coffee and Tea Estates by owners themselves for various reasons like labour shortage, poor yield, price fluctuation etc.
- iii) Under the New Agriculture Export Policy, Government of India has identified 31 clusters across the Country. In Tamil Nadu, Theni and Trichy have been identified for Banana. Lot of interventions are going to flow into these clusters. Some other clusters for specific produce like Moringa and Amla may be proposed by the State for the consideration of Government of India. The APC & PS assured that the department will get in touch with the Director, Trade, GoI in this regard to get his ideas and suggestions to move forward in this regard.
- iv) The Commissioner of Agricultural Marketing & Agri Business pointed out that there is lack of awareness among the officials and farmers regarding world trade. The ACS, Finance suggested that a training programme or work shop may be arranged and the Shri. Vijaya Rajmohan, Director, Trade GOI may be invited to make a presentation on world trade and related subjects.
- v) There is scope for growing Quinoa in dry tracts of Tamil Nadu such as Ramanathapuram, Perambalur as done in the Anantapur district of Andhra Pradesh.

In Rajasthan also it is propagated by distributing seed kits and now some 1000 to 1500 farmers are growing quinoa. It is considered as a Health food and priced around Rs.500/- per Kg. Since it requires a processing plant, a visit to Andhra Pradesh would help in studying the model and replicate it in Tamil Nadu.

The CS and the ACS, Finance appreciated the APC & PS for conducting the State Level Sanctioning Committee meeting much ahead this year so that process is not delayed due to the oncoming Elections. The ACS, Finance expressed his satisfaction that the approved projects can be implemented as soon as the funds are released by Government of India.

The Meeting ended with Vote of Thanks by the Agricultural Production Commissioner & Principal Secretary to Government, Agriculture Department.
