Minutes of State Level Sanctioning Committee (SLSC) Meeting of Rashtriya Krishi Vikas Yojna (RKVY) held under the Chairmanship of Chief Secretary JKUT (Chairman SLSC) in the Meeting Hall, 3rd Floor at Civil Secretariat Jammu on 16-06-2020 at 12.30 AM.

As per Operational Guidelines of RKVY RAFTAR, a meeting of State Level Sanctioning Committee (SLSC) was held on 16.06.2020 at 3rd Floor Civil Secretariat Jammu under the Chairmanship of the Chief Secretary JKUT to review the progress made during 2019-20 under the Scheme and to discuss Proposed Annual Action Plan under RKVY for financial year 2020-21. Following Officers attend the meeting annexed at "A".

1. At the outset the Mission Director RKVY Director Agriculture Kashmir gave a brief introduction of RKVY before the Committee and presented broad outline for doubling the farmer's income in the JKUT through integrated approach.
2. After due deliberation the State Level Sanctioning Committee (SLSC) approved the broad allocations under RKVY for FY 2020-21 for an amount of Rs. **7579.944** Lacs.
3. The SLSC considered and approved Department-wise proposals recommended by the State Level Project Screening Committee (SLPSC) mentioned hereunder for submission to the Ministry of Agriculture and Farmers Welfare Government of India for seeking release of funds and thereafter its utilization in a time bound manner.

4. The Chairman SLSC emphasised that Plan needs to be implemented in accordance with the guidelines of RKVY issued by Government of India. The Chairman further impressed upon the Departments to improve the pace of expenditure and execution of works so that more funds could be utilized in full.
5. The Action Plan for the year 2020-21 shall be implemented through DBT mode and the procurements be made through GeM (Government e-Marketing Portal) and e-tendering, wherever required as per the guidelines of the Scheme.
6. Chairman SLSC conveyed that implementation of all Proposed interventions should be adopted in cluster mode for creating an forceful economic impact in the cluster so that a successful model could be replicated in other regions for economic gains to the farming community which would be a step forward for doubling the farmers income by 2022.
7. All UCs and performance reports shall be submitted within the time frame.
8. To the extent possible, Assets created by RKVY should be captured digitally and be mapped on GIS Plate form for further integration on National GIS System.
9. The Chairman has desired to frame Steering Committee to hold monthly meeting to review the implementation of the Scheme.
