Minutes of the 18<sup>th</sup> Meeting of the State Level Sanctioning Committee (SLSC) of Rashtriya Krishi Vikas Yojana/ National Agriculture Development Programme held on 26.02.2020.

The 18<sup>th</sup> meeting of the State Level Sanctioning Committee of Rashtriya Krishi Vikas Yojana/ National Agriculture Development Programme was held under the Chairmanship of the Chief Secretary to Government to discuss and approve the projects for the year 2020-21 under NADP. SLSC members and heads of NADP implementing Departments and other officials participated in the meeting.

# List of participants is annexed.

At the outset, the Agricultural Production Commissioner and Principal Secretary to Government, Agriculture Department extended his welcome to the Chief Secretary & Chairman of the SLSC, Additional Chief Secretary (Finance), Additional Chief Secretary (Municipal Administration and Water Supply Department), Principal Secretary (Animal Husbandry, Dairying and Fisheries), Additional Chief Secretary (Planning & Development), Principle Secretary to Government (Environment and Forests department) and all other members and senior officers. The APC & PS introduced the Government of India representative, Shri.Ganesh Singh, Under Secretary, RKVY Division to the members and participants.

The APC & Principal Secretary to Government informed the committee that before the SLSC meeting, several meetings were conducted with the Heads of implementing departments of both agriculture and allied sectors in the presence of the Principal Secretary, Animal Husbandry, Dairying and Fisheries and other Secretaries wherein the projects proposed were discussed and the prioritization of projects was done as RKVY-RAFTAAR scheme is considered as a very important scheme by Government of Tamil Nadu. The APC & PS informed that Tamil Nadu is the first State to hold the SLSC for the year 2020-21.

The APC & Principal Secretary to Government informed the Committee that Government of India have broadly communicated that the allocation for 2020-21 will be the same as that of the year 2019-20 which is Rs.277.85 crore. As per the RKVY guidelines, projects to the tune of 150% of previous year have to be approved by the SLSC and considering the total allocation to be Rs.277.85 crore, the projects for the year 2020-21 have been prepared for Rs.435.056 crore (excluding 4 projects proposed for Rs.9.507)

crore on priority from the shelf of projects) which is 156% of the allocation of 2019-20. Though the total outlay proposed is Rs.444.563 crore, priority projects will be taken up based on the allocation and the remaining projects will be kept under shelf of projects to be taken up if additional allocation is received.

The APC & Principal Secretary to Government informed the committee that the allocation to allied sectors used to be 15% to 16 % earlier and the allocation has increased gradually during the years 2018-19 and 2019-20 to 23 % and 24 % and for the year 2020-21 the projects proposed under allied sector occupy 29%.

The APC & PS explained the committee that every year Tamil Nadu gets good allocation under RKVY including the sub-schemes and during 2019-20, Tamil Nadu has received both the instalments from Government of India as per the allocation and the Government orders have been issued except for the second instalment GOs of Fisheries Department and additional allocation for Tamil Nadu Dr.J.Jayalalithaa Fisheries University (TNJFU). With regard to the sub-schemes Cashew Area Expansion and Crop Diversification Programme 2019-20, the second instalment release is pending with the Gol and it will also be received soon.

The APC & Principal Secretary to Government, quoting the Additional Secretary, Gol informed that the State is likely to receive an additional allocation of upto Rs.50 crore during 2019-20 itself which will be allocated on priority basis to the projects from the shelf of projects approved already by the SLSC. Department wise performance for the year 2019-20.

#### Discussion:

The APC informed the Committee that the progress shown in the presentation is based on the latest report given by the departments. He pointed out that the overall

financial achievement made so far is 70%. The APC while replying to the Chief Secretary's query on the lowest achievement in Seed Certification department informed that the project "Construction of New Integrated Seed Certification Complex at Kattuthottam, Thanjavur District" was sanctioned for an outlay of Rs.2.35 crore additionally during the month of January 2020 and it will be completed on time. The Sugar department was also sanctioned Rs.5 crore during January 2020 as second instalment as per the allocation and this will also be completed before 31<sup>st</sup> March 2020. The overall expenditure with respect to Agriculture Sector is 70%.

The APC informed the Committee that joint review meetings are held by the Principal Secretaries of Agriculture and Animal Husbandry, Dairying & Fisheries apart from convening independent review of progress of NADP projects with the HoDs by the APC & PS and PS, AHD&F.

The APC stated that Rs.21.68 crore sanctioned to the Animal Husbandry department for the project "Establishment of livestock Complex at Chinnasalem Farm" has been utilized for the construction of the multi-facility infrastructure at the Advanced Institute for Integrated Research on Livestock and Animal Sciences (AIIRLIVAS) at the project site for which a ratification proposal has been submitted as a Table Agenda. The overall expenditure with respect to Allied Sector is also 70%.

The progress under the sub schemes of NADP/RKVY were also presented during the meeting and the expenditure under Cashew Area Expansion and Crop Diversification programme is 100% against the 1<sup>st</sup>insatlment release. The 2<sup>nd</sup> instalment is awaited from Gol for the above said sub schemes. Under "Reclamation of Problem Soils – sub scheme" the G.O was issued on 04.12.2019 and the works are under progress. The Chief Engineer, Agricultural Engineering department informed that the civil works viz., Construction of weir to prevent the intrusion of sea water in to the fields, channel stabilizer, Bed dam, pipe outlet etc., may not be completed before March 2020 and the second instalment release from Gol may not be received. The Chief Secretary advised the Chief Engineer, Agricultural Engineering department to revise the proposal according to the 1<sup>st</sup> instalment amount as it was informed that the RPS sub-scheme will be merged with normal RKVY next year and it may not be possible to get the Gol liability during next year.

The Chief Secretary was informed that "Rabies Vaccination in Canine" & "Establishment of Glanders Surveillance unit" activities under Animal Health sub scheme of RKVY during the year 2019-20 were approved and the Gol has released the first instalment only during the January 2020 and the G.O is under issuance. The Chief

Secretary advised to get the G.O earlier and complete the activities before March, 2020. The CS requested all the HoDs to expedite the implementation of all the projects.

# Agenda IV

# Project Proposals for the Year 2020-21

The APC stated that, for the year 2020-21, projects have been proposed for an amount of Rs.435.056 crore and Rs.9.507 crore under Shelf of projects of 2019-20 requested during 2020-21 to accommodate more projects and take them up on priority basis based on the final allocation. The projects were finalized in consultation with officers in such a way as to fit into the budgetary announcement/budgetary proposals for like special packages like Fall Army Worm Management, Kuruvai package made by the Government.

The APC informed the Committee that a pre scrutiny meeting was held at the Government of India level on 24.02.2020 at Krishi Bhawan and the remarks of the divisions of the Ministry of Agriculture, Government of India have been communicated for each project.

Also, for all the projects, details of locations and location wise physical & financial targets need to be furnished to Government of India. The Gol have commented that geo tagging needs to be done for all the infrastructure & Assets projects. Detailed Estimates and drawings need to be furnished to all the infrastructure projects. DBT should be ensured for individual based projects.

The Chief Secretary advised to prioritize the projects exactly to the budgetary allocation of last year that is 294.389 crore including sub schemes in the phase I and subject to availability of funds, phase II projects have to be taken up to have the clarity of works to be taken up in the current year. Accordingly, the overall project categorization also should be changed according to the prioritized projects.

The APC presented the overall budget abstract for the year 2020-21 and requested the Heads of implementing departments to present their projects before the Committee.

# Project Proposal No. 18.1

Project Title

: Special Package for bringing fallow lands into Cultivation

Implementing Department

: Department of Agriculture

**Project Cost** 

Rs.10.40 Crore

Remarks of Gol

Supported as per NFSM/SMAM norms where applicable. For other component RKVY norms with 25% subsidy may be approved & for such components reasonableness of cost may be certified by SLSC. Geo-tagging to be done. DBT may be ensured. Location may be indicated.

Discussion

The Director of Agriculture explained that in Tamil Nadu 22.52 lakh ha area is under fallow including both other fallows and culturable wastes (fallow for more than 5 years) and current fallow (fallow for less than 3 years) is 9.91 lakh ha. From the other fallow and culturable waste category, 10,000 ha has been proposed for in this project for bringing fallow lands into cultivation on pilot basis.

Since the fallow lands amount to almost 20% with respect to total geographical area, the Chief Secretary opined and emphasized the point raised by the Additional Chief Secretary, Finance and ACS, Planning that the project should be taken up in clusters on demonstration basis and it should cause a triggering effect among the farmers to replicate the same in other areas.

The reason for lands (for eg. Absentee land lordism) lying as fallow for long periods needs to be examined carefully. This problem has to be studied properly. The ACS, Finance expressed that there is a mix of issues involved in the fallow lands and farmers of Southern districts of the State are considering the *Prosopis juliflora* economically viable when compared to farming.

The Chief Secretary requested the VC, TNAU to conduct a study on the fallow land problem by taking district wise figures and find out whether there is significant increase in other fallow and culturable waste in southern districts and also pick up one or two districts for ground study to find out why that number has suddenly spiked and give the remedial measures to bring back those lands into cultivation.

The Executive Director (FAC) suggested that the watershed development and bringing fallow land under cultivation activities can be combined for sustainable change and bringing back the fallow lands to cultivation.

Reacting to Gol comments, the DoA informed that assistance of Rs.7100/- per Ha proposed for land

development activities is **less than 25%** as the PWD cost norm is Rs.52,000/- per Ha and 25% of which works out to Rs.13,000/- per Ha. Assistance for Seed Drill sowing is as per SMAM norms. All other components like seeds and other inputs **except Farm Yard Manure** are proposed as per NFSM norms which allows 50% assistance.

Resolution

SLSC resolved to approve the project for Rs.10.40 crore subject to the condition that the project has to be taken up on cluster basis as model demonstration for the other farmers to emulate and assistance for FYM is to be restricted to 25% as per RKVY norms.

Proposal may be dropped. Approval of CIBRC may be sought

Discussion

The Director of Agriculture informed that the Gol remarked during the pre SLSC meeting to get the approval of CIBRC or may be dropped. Based on the suggestion given by the ACS (Planning) and APC, the Director of Agriculture informed that the project will be sent to CIBRC for approval.

The Chief Secretary informed that in the usage of drones, there are some regulatory issues. The regulatory frame work should be drawn first like eligibility of people to own the drones, the clearances that should be got, the spraying charges etc. The list of recognized drone companies meeting the regulations should be drawn by the Department for recommending to farmers.

Resolution

The SLSC resolved to give in-principle approval to the project subject to the approval of CIBRC.

approved & for such components reasonableness of cost may be certified by SLSC. Geo-tagging to be done. DBT may be ensured. Location may be indicated.

#### Discussion

: The Sunflower and Castor components are proposed as per the NFSM Oilseeds - Cluster Demonstration norms. In respect of Redgram Transplantation, components such as Seed, Trichoderma viridi, MN mixture, Liquid Biofertilizer, Weedicide and Line sowing are proposed as per NFSM norms. The remaining components - Protray with 100 pits, Sand & FYM, preparation & filling up of portray culture and maintenance will be restricted to 25% assistance.

#### Resolution

SLSC resolved to approve the project with a condition that the components like protray with 100 pits, Sand & FYM, preparation & filling up of protray culture and maintenance should be restricted to 25% assistance as per RKVY –RAFTAAR guidelines.

Remarks of Gol

PP Division: The interventions proposed are in line with the recommended Package of Practice for the management of FAW. Overall, the proposed project is good with a motive to support farmers and reduce crop loss through Integrated Pest Management.

RKVY Division: Supported as per PP Division Comments. CIB&RC registered pesticides & bio-pesticides may be used. Certification of reasonableness of cost from SLSC may be obtained. Location may be indicated.

#### Resolution

The SLSC resolved to approve the project for Rs.20 crore subject to the condition that the remark of Gol that CIB&RC registered pesticides & bio-pesticides may be used should be complied with.

# Project Proposal No. 18.5

Project Title

: Promoting Mechanization in Groundnut harvesting

Implementing Department

: Department of Agriculture

**Project Cost**

Comments of Gol

: Supported as per SMAM norms. Geo tagging to be done.

Location may be given.

Discussion

The Director of Agriculture informed that the area under Groundnut crop is decreasing in Tamil Nadu due to the problem of labor scarcity.

The Chief Secretary opined that instead of these kinds of demonstrations, the Agro Service Centres should be encouraged to purchase the ground nut harvesters where the Groundnut area is vast. Custom Hiring Centres promoted by Agricultural Engineering Department also should be made to purchase these in groundnut belts.

Resolution

The SLSC resolved to approve the project on last priority.

# **Project Proposal No. 18.6**

**Project Title** 

: Accurate application of Nutrients through drip irrigation in cotton

Implementing Department

: Department of Agriculture

**Project Cost** 

: Rs.0.375 Crore

Comments of Gol

: In the standard drip irrigation list, nutrients are included so it may be clarified why this component is being asked for.

Discussion

The APC and the Director of Agriculture have informed that the project is to promote the Water Soluble Fertilizers developed by TNAU under NADP.

The Chief Secretary opined that the manufacturing unit for the production of water soluble fertilizers with 50% subsidy to the Cooperatives, FPOs and others may be proposed since the water soluble fertilizers are still imported. So the import substitution may happen.

Resolution

: The SLSC resolved to approve to the project on last priority subject to submission of clarification on Gol comments.

**Project Title** 

: Paddy Production improving interventions

Implementing Department

Department of Agriculture

**Project Cost** 

Rs.55.584 crore

Comment of Gol

a) Promoting seed production of Newly released varieties (less than 10 year varieties) - Supported as per NFSM/SMAM norms where applicable. For other components, RKVY norms with 25% subsidy may be approved & for such components reasonableness of cost may be certified by SLSC. Geotagging to be done. DBT may be ensured. Location may be indicated.

Reply of the Department: Seed production incentive is proposed @ Rs.8 per Kg. The procurement price of certified paddy seed is Rs.32.60 per Kg and hence the assistance proposed is less than 25% as per RKVY guidelines.

- b) Distribution of Newly Released Varieties (Less than 10 year varieties)-Supported as per NFSM norms. DBT may be ensured. Location may be indicated. Certification of reasonableness of cost from SLSC may be obtained.
- c) Promoting seed production of Newly released varieties (less than 10 year varieties) through FPOs Supported as per NFSM/SMAM norms where applicable. For other components RKVY norms with 25% subsidy may be approved & for such components reasonableness of cost may be certified by SLSC. Geo-tagging to be done. DBT may be ensured. Location may be indicated.

Reply of the Department: Seed production incentive is proposed @ Rs.8 per Kg. The procurement price of certified paddy seed comes to Rs.32.60 per Kg and hence the assistance proposed is less than 25% as per RKVY guidelines.

d) Water conservation and labour saving technique through SRI/Machine Planting - Supported as per RKVY-RAFTAAR (25% subsidy). Certificate of reasonableness of cost may be obtained from SLSC. Geo tagging to be done. Location may be given.

Reply of the Department: There is a provision for organizing cluster demonstrations in SRI @ Rs 9000/ha under NFSM Rice (8 districts alone). In this proposal, the assistance for seed and machine planting were considered at 50% subsidy excluding other components.

e) Seed drill sowing (450.00) - Supported as per SMAM cost norms. DBT may be ensured. Geo-tagging to be done.

f) Nutrient conservation and Farm soil preservation, Agro Eco system analysis, Management of post-harvest losses through distribution of movable threshing floor/Tarpaulins & Publicity and other contingencies - Supported as per RKVY-RAFTAAR (25% subsidy). Certificate of reasonableness of cost may be obtained from SLSC. Geo tagging to be done. Location may be given.

Reply of the Department: Biofertilizers, MN Mixture, Weedicides and Psuedomonas are proposed as per NFSM norms. Copper Sulphate application is proposed for the first time in areas which show acute deficiency and considerable yield loss. The assistance will be restricted to Rs.500/- per Ha as per NFSM norms for Micro Nutrient mixture.

Agro Eco System analysis has been approved under local initiative-NFSM Rice 2019-20 vide GOI Lr.No 2-25/2019-NFSM dated. 18.04.2019.

Tarpaulin has been approved under local initiative-NFSM 2019-20 (250 GSM, size 6X5 mts Subsidy Rs.1500/No) vide GOI Lr.No 2-25/2019- NFSM dated. 18.04.2019.

Discussion

The Director of Agriculture gave the justification for the Gol comments and requested the Committee to approve the assistance proposed based on the justification. The Chief Secretary asked to widely promote the promising newly released TNAU varieties. DoA informed that assistance for Paddy seed production is given to encourage newly released TNAU varieties like CR 1009 sub-1 and CO-53.

Resolution

The SLSC resolved to approve the proposal with a condition that assistance for Copper Sulphate should be restricted to Rs.500 per ha.
