Minutes of the State Level Sanctioning Committee (SLSC) Meeting of RKVY-RAFTAAR, ATMA and PMKSY-BKSY held on 23<sup>rd</sup> December, 2020 at 11:00 hrs at Conference Hall of the Chief Secretary, Nabanna, through Webinar

The meeting was chaired by the Chief Secretary to the Government of West Bengal and Chairman, SLSC Sri Alapan Bandyopadhyay. Due to pan-India ongoing lockdown, and to maintain Covid-19 protocol, the GOI suggested to get approval of the Chairman of SLSC vide their letter No. 7-1-RKVY, DAC&FW, GOI dated 26/05/2020 subject to post facto approval of SLSC. The GOI has requested to hold the SLSC meeting of RKVY (including sub-schemes) through Webinar Vide No. 7-1/2020-RKVY dated 25/11/2020. For best use of the time, in terms of existing practice, the SLSC of ATMA and PMKSY were also held together. Shri P.K. Swain, Joint Secretary, Marketing & AMA, DAC&FW, GOI and Nodal Officer for West Bengal, Shri Upamanyu Basu, Joint Secretary (LH), Department of Animal Husbandry & Dairying, GOI and Shri J. Das, Director of Jute Development, GOI joined the meeting through Webinar from Government of India and Dr. Neelam Patel, Sr. Adviser (Agriculture) joined from NITI Aayog. The heads of stakeholder Departments and other members from West Bengal joined / physically through webinar.

List of participants attended / joined the meeting is annexed (Annexure-A).

The Chairman requested Shri S. K. Gupta, Additional Chief Secretary, Agriculture Department to initiate the discussion. The ACS welcomed the officials for attending / joining the meeting and apprised the House that due to prevailing pandemic Covid-19 the state could not hold the SLSC meeting in due time. He briefly discussed the agenda of the meeting and requested Shri P. Hans, Special Secretary, Agriculture Department to deliver power point presentation on RKVY and sub-schemes implementation in the state.

# Agenda II: RKVY and Sub-schemes:

1) Post facto approval of the projects approved by the Chief Secretary & Chairman, SLSC:

Based on the recommendation of State Level Project Screening Committee (SLPSC) (meeting held on 18<sup>th</sup> February, 2020) of RKVY-RAFTAAR, the draft Annual Action Plan was sent to GOI on 11/03/2020 for an amount of Rs. 647.647 crore which comprised of 105 nos. of new projects with an outlay of Rs. 575.07 crore and 14 nos. of ongoing / spill over projects with an outlay of Rs. 72.58 crore. The project breakup for stakeholder Departments is given at **Annexure-I.** However, due to declaration of lockdown to combat Covid 19 pandemic, the SLSC meeting could not be held as usual. For implementation of RKVY-RAFTAAR during 2020-21, GOI has communicated (Vide No. 1-29-1-2020-RKVY/1-3 dt. 02/07/2020) regarding allocation of RKVY-RAFTAAR for West Bengal during 2020-21 to the tune of Rs. 154.59 Crore with matching State share is Rs. 103.06 Crore.

GOI has released Rs. 38.94 Crore as central share, corresponding state share is Rs. 25.96 Crore. Thus total release (CS+SS) is Rs. 64.90 Crore.

GOI has communicated their observation / comments on the RKVY-RAFTAAR projects in three (3) phases:

- (i) Vide No. 1-29/2020-RKVY dt. 04/06/2020.
- (ii) Vide F. No. 1-29/2020-RKVY dt. 31/07/2020.
- (iii) Vide F. No. 1-29/2020-RKVY dt. 29/09/2020

Further, GOI vide No. 7-1/2019-RKVY dt. 26/05/2020 requested to implement the DAC&FW recommended projects with approval of the Chief Secretary and Chairman, SLSC subject to post facto approval by the SLSC. Accordingly, the State Nodal Department sought approval of all such DAC&FW recommended RKVY projects for implementation during 2020-21 and circulated the same to the stakeholder Departments as stated below:

- (i) On 11/06/2020, the Chairman, SLSC approved 21new projects (3 stakeholder departments) with project cost of Rs.126.89 Cr. and 8 ongoing projects (3 stakeholder departments) with project cost of Rs.12.56 Cr. This was circulated vide no. 534-AG/O/9M(Nab.)-169/2019 dated- 16/06/2020.
- (ii) On 13/07/2020, the Chairman, SLSC approved 2 new projects of Agriculture Department with approved cost of Rs. 8.94 Cr. and 1 ongoing project (of ARD

Department with approved cost of Rs. 30.60 Cr. This was circulated vide no. 673-AG/O/9M(Nab.)-169/2019 dated- 15/07/2020.

- (iii) On 19/09/2020 the Chairman, SLSC approved 5 new projects (2 stakeholder Departments) with approved cost of Rs.22.379 Cr. This was circulated Vide no. 922-AG/O/9M(Nab.)-169/2019 dated- 18/09/2020
- (iv) On 16/10/2020, the Chairman, SLSC approved 8 new projects (4 stakeholder Departments) with approved cost of Rs. 32.1243 Cr. This was circulated vide no. 1072-AG/O/9M(Nab.)-169/2019 dated- 16/10/2020.

Thus total approved cost for 36 new RKVY-RAFTAAR projects stands at Rs.190.34 Cr. and total approved cost for 9 ongoing project stands at Rs.43.15 Cr. Thus cost for 45 nos. (New Projects + Ongoing Projects) stands at Rs. 233.49 Cr.

The list is placed at Annexure-II.

Post facto approval may be accorded to above 45 (36 new plus 9 ongoing) projects.

#### Decision:

- i) The House accorded post facto approval of 36 new and 9 ongoing projects as stated in annexure –II for implementation during 2020-21.
- ii) The House approved rest of the projects (where GOI comments are yet to be received) in principle subject to final comments of the DAC&FW, GOI.
- iii) The House further requested GOI representative to pursue the issue of pending comments from GOI on 24 new projects of 4 stakeholder Departments, as the year is almost closing.

### 2) Review of utilization of unspent balance of RKVY, 2017-18:

An amount of Rs. 375.88 crore (including State share) was released under RKVY for 2017-18 in two instalments. Out of this total amount, expenditure statement of Rs. 374.46 crore has been received up to 30/07/2020. On request, Govt. of India has revalidated unspent Central share of Rs. 0.9877 Crore out of total unspent fund is 1.42 Crore vide No. 1-29/2020-RKVY dated 23/12/2020.

The status of expenditure of RKVY fund during 2017-18 is given at **Annexure- III.** 

#### Decision:

The House requested the stakeholder Department to expedite the utilization.

### 3) Review of utilization of fund of RKVY-RAFTAAR 2018-19:

An amount of Rs. 324.7848 crore (including State share) was released under RKVY for 2018-19 in two instalments. Out of this total amount, utilization certificate of Rs. 275.79 crore (CS+SS) has been sent to GOI on 03/03/2020.

As a measure of fund management and for immediate utilization of unspent fund under RKVY-RAFTAAR 2018-19, Fisheries Department has surrendered an amount of Rs. 12.8175 Crore out of total allotted fund of Rs. 35.5835 Crore, vide No. 1920-FI- 25014(14)/1/2019 dt. 15/11/2020 and Finance Department U.O. No. 2270 dt. 16/10/2020 and the same has been allotted to Agriculture Department vide FD UO No. 2754 dt. 28/11/2020.

Rs. 301.2373 crore has been utilized and updated Utilization status (as on 30/11/2020) is placed at **Annexure-IV**.

#### Decision:

The House emphasized that the State has missed 2<sup>nd</sup> instalment of 2019-20 due to want of full utilization certificate and requested the defaulter stakeholder Departments viz. WRID and Agriculture Department (BCKV) to submit 100% UC immediately.

## 4) Review of progress of RKVY, 2019-20:

During 2019-20 an amount of Rs. 136.75 crore (CS+SS) was released as 1<sup>st</sup> instalment. Out of this total amount, utilization certificate of Rs. 80.6732 crore (CS+SS) has been sent to GOI on 03/03/2020. The state missed 2<sup>nd</sup> instalment.

As a measure of fund management and for immediate utilization of unspent fund under RKVY-RAFTAAR 2019-20, Fisheries Department surrendered an amount of Rs. 15.6824 Crore vide No. 1920-FI-25014(14)/1/2019 dt. 15/11/2020 and FD UO No. 2270 dt. 16/10/2020 out of which-

- (i) Rs. 12.1824 Crore allotted to Agriculture Department vide FD UO No. 2754 dt. 28/11/2020.
- (ii) Rs. 3.50 Crore allotted to I&W Department.

Rs. 100.97 crore has been utilized till date and updated status (as on 30/11/2020) is placed at **Annexure-V**.

#### Decision:

The House expressed anxiety over utilization of only 83.3% (Rs. 113.95 Crore) of the allotted fund (Rs. 136.75 Crore) inspite of the State not receiving 2<sup>nd</sup> instalment in 2020-21 and requested the defaulter stakeholder Departments viz. WRID, Fisheries, Food & Supplies and I&W to expedite utilization of fund so that 100% utilization can be achieved immediately.

# 5) Review of progress of RKVY, 2020-21:

During 2020-21, an amount of Rs. 64.90 crore (CS+SS) was released (this is only 25% of overall allocation) as 1<sup>st</sup> instalment and the same was sub-allotted to 4 stakeholder Departments (Agriculture, ARD, Agri. Marketing and FPI & Horticulture). Out of this total amount, till date we have received utilisation of Rs. 34.28 Cr. (CS-21.59 Cr.+ SS-12.69 Cr.) i.e. 53% of released fund as central and state share. **Annexure-VI.** 

#### Decision:

The state Nodal Department will submit proposal for release of 2<sup>nd</sup> instalment of central share with updated utilization certificate of RKVY-RAFTAAR fund within a couple of days.

# 6(i) (a) Post-facto Approval of BGREI Action Plan for the year 2020-21 including unspent revalidated fund of 2019-20.

Action Plan of BGREI, 2019-20 as recommended by GOI vide File No.6-8/2019-NFSM, Dt.04-06-2019 along with Revised Action Plan of BGREI-Rice, 2019-20 as recommended by GOI vide File No.6-8/2019-NFSM, Dt.16-10-2019 and also Action Plan of BGREI for the year 2020-21 including Unspent Balance of BGREI, 2019-20 as approved by GOI vide File No.6-8/2020-NFSM, Dt.17-09-2020 & File No.6-8/2020-NFSM, Dt.24-06-2020 are being placed before the House for post-facto approval.

#### Decision:

The House approved BGREI revised Annual Action Plan of 2019-20 for an amount of Rs. 94.19 Crore and BGREI revised Action Plan of 2020-21 for Rs. 82.13 Crore (CS+SS) including Rs. 5.42 Crore unspent balance of 2019-20 for implementation during 2020-21.

### Review of utilization of fund under BGREI for 2019-20:

**During the FY 2019-20,** under BGREI, a total fund of Rs. 90.00 crore (Rs.54.00crore as Central Share and Rs. 36.00 crore as State Share) was released. Utilization Certificate of Rs.84.5818crore (Rs.50.1152crore as Central Share and Rs.34.4666 crore as State Share), i.e. 94% w.r.t fund release and its relevant Progress Report were submitted to GOI by the Agriculture Department (Annexure-VII).

**During FY 2020-21**, under BGREI, unspent Balance of Rs. 5.4182 crore (Rs.3.8848 crore as Central Share and Rs.1.5334 crore as State Share) of BGREI, 2019-20 lying with the State has duly been revalidated and released. 100% Utilization Certificate of Rs. 5.4182crore (Rs.3.8848 crore as Central Share and

Rs.1.5334 crore as State Share) along with relevant Progress Report and also Consolidated Progress Reports of BGREI, 2019-20 have already been submitted to GOI by the Agriculture Department **Annexure-VIII**.

#### Review of utilization of fund under BGREI for 2020-21:

During the FY 2020-21, under BGREI, GOI approved Action Plan for BGREI-Rice during 2020-21 including Unspent Balance of BGREI, 2019-20 (Rs. 5.4182 crore) was Rs. 82.13 crore (Annexure-IX). Hence, Action Plan of BGREI-Rice, 2020-21 (excluding USB of 2019-20) was Rs.76.712 crore [Central Share Rs.46.027 crore + State Share Rs.30.685 crore].

Out of Rs.76.712 crore under BGREI-Rice, 2020-21, Rs.32.066 crore [Central Share Rs.19.24 crore + State Share Rs.12.826 crore] has been released as 1<sup>st</sup> instalment fund. Utilization Certificate of Rs. 22.50crore [Central Share Rs.13.564 crore and State Share Rs. 8.936 crore], i.e., 70% UC along with its relevant Progress Report have already been submitted to GOI by the Agriculture Department for release of 2<sup>nd</sup> instalment fund.

At present, Rs. 26.30crore [Central Share Rs. 15.50 crore and State Share Rs. 10.80 crore], i.e., 82% of 1<sup>st</sup> instalment fund has been utilised (**Annexure-X**).

The House was apprised that GOI has released Rs. 20.47 Crore as 2<sup>nd</sup> instalment under BGREI 2020-21 which is Rs. 6.317 Crore less as per approved Action Plan. Hence, it is apprehended that there will be committed liabilities due to short release of central share.

#### **Decision:**

- (i) The House appreciated the progress of work done in 2019-20 & 2020-21 and impressed upon speedy implementation of the sub-scheme as per approved action plan.
  - (ii) The GOI is requested to release balance CS fund of Rs. 6.317 Crore.
- 6(ii) Post facto approval of Annual Action Plan of Crop Diversification Programme (CDP) under RKVY for Replacing Tobacco farming with alternate crops/cropping system of 2020-21:

The Govt. of India has accorded approval (vide no. F. No. 1-14/2020-CU-II dated-19/08/2020) of AAP for implementation of CDP to the tune of Rs.0.4620 crore (including arrear liability of Rs. 0.0595 crore) with Central Share: State Share @ 60:40. The Action Plan has been approved by the Chairman, SLSC on 04.11.2020 subject to post-facto approval in the next SLSC (Annexure-XI)

Post facto approval may be accorded.

#### Decision:

The House approved the CDP Action Plan 2020-21.

Review of Crop Diversification Programme (CDP) Action Plan 2019-20: During 2019-20, an amount of Rs. 0.15 crore (CS+SS) was released as 1<sup>st</sup> instalment out of approved outlay of Rs. 0.3078 crore (CS+SS). Full utilization certificate of Rs. 0.15 crore (1<sup>st</sup> instalment) has been submitted to GOI on 20/02/2020. An amount of Rs.0.2095 Cr. (CS+SS) was incurred towards implementation of the sub-scheme. Arrear liability of Rs. 0.0595 crore has been

# 6(iii) Review of RKVY-RAFTAAR Sub-scheme: Area Expansion of Cashew, implemented by FPI & Horticulture Deptt.

During 2019-20 an amount of Rs. 0.30 crore (Rs. 0.18 crore CS and 0.12 crore SS) was allotted to FPI & Horticulture Department as 1<sup>st</sup> instalment. Work could not be done as the planting season was over. Fund was revalidated by GOI for utilisation during 2020-21.

#### Decision:

The House expressed anxiety and requested FPI & Horticulture Department to expedite utilization of fund.

# 6(iv)(a) Review of RKVY-RAFTAAR Sub-scheme: 'Brucella Control' implemented by ARD Deptt.

The project namely, "Brucellosis Control Programme in the State of West Bengal" under Animal Health sub-scheme under RKVY 2018-19 was approved in FY 2018-19. Against a budgetary allocation of Rs. 3.75 crore GOI released 1<sup>st</sup> instalment of Rs. 1.125 crore vide No. 1-29/2018-RKVY Dt. 22/01/19 and the matching state share of Rs. 0.75 crore has also been credited in the FY 2019-20. The fund for Brucellosis Control Programme amounting Rs. 1.875 crore (CS+SS) has not yet been utilized.

#### (b) Review of new sub-scheme – "Animal Health Sub-scheme" 2019-20:

The GOI has released an amount of Rs. 0.83 crore for implementation of Animal Health Sub-scheme during 2019-20 as 1<sup>st</sup> instalment (vide no. 1-29/2019 dt. 17/12/2019) and the corresponding state share of Rs. 0.55 crore has also been released (Total Rs. 1.38 crore).

No utilization certificate submitted till date.

#### **Decision:**

The House expressed anxiety over the pace of utilization and requested

ARD Department to expedite utilization and submit utilization certificate of the funds released under both the sub-schemes urgently.

# 7) Geo-tagging of assets and RDMIS (RKVY Database Management Information System).

(1) Geo-tagging: A hands-on training on Geo-tagging of RKVY assets along with review meeting was organized by this State on 11/12/2019 with technical support of NRSC / ISRO to review the status on July 2019. The target is 25,000 (ref. D.O. No. 7-1/2018-RKVY dated 28/03/2019 of GOI) and all assets having cost of Rs. 1000/- or above. There are immense scopes to improve the geo-tagging, especially, in the "Marketing Postharvest" segment. The number of assets geo-tagged has improved from 8,717 in July, 2019 to 16,714 on the morning of the SLSC meeting. Detailed status of geo-tagging till 30.11.2020 is given at Annexure-XII.

#### Decision:

The stakeholder Departments were requested to complete geo-tagging all assets created under RKVY pending for Geo-tagging at the earliest.

# (2) RDMIS (RKVY Database Management Information System):

For transparency of utilization of Government fund and proper monitoring, updating of records in RDMIS is mandatory. Pending list is big, however, varying from Department to Department.

#### Decision:

All the stakeholder Departments are requested to update progress of RKVY in RDMIS time to time with progress of physical work.

#### 8) Miscellaneous:

1) I-Win Advisory Service was engaged for undertaking **Third Party**Evaluation for assessment (both impact & concurrent) of technology
Demonstration Centres (DCs) of Kharif Paddy 2017 and Kharif Paddy
2018 under RKVY including BGREI. **The final report is placed before**the SLSC for approval.

#### **Decision:**

The House approved the third party evaluation report.

2) RKVY-RAFTAAR **Agri-Business Incubator (R-ABI),** IIT, Kharagpur has been entrusted by the MOA&FW, GOI as RKVY-RAFTAAR R-ABI they are providing training to prospective farmers on Agripreneurship Orientation (AOP) and Start up Agri-Business Incubation (AIP) for

entrepreneurship development in Agriculture sector.

#### Decision:

The House appreciated the initiative.

# 3) Proposal for Post facto approval:

- a) While setting up "Integrated Workshop on Farm Mechanization" at ATC, Narendrapur for the year 2019-20, the authority have purchased a few important machines beyond approved list like combine harvester, transplanter, garden tools, workshop related repairing tools within the overall approved cost. These have been utilised for developing human resources which have supported for better services by the Farm Mechanization Workshop. Implementing department-Agriculture.
- b) A few inter-component changes in expenditure for the project **Breeder Seed Production Programme of Potato with integration of Micro Propagation system** under RKVY-2017-18 to 2019-20 have been made within overall approved cost for better benefits. The total intercomponent changes involve Rs. 0.511 crore within the current project cost of Rs. 3.594 crore. Implementing department-Agriculture.
- c) The proposal on "Rural Start-Up in Production of Pulse Seeds and Other Planting Materials through Integration of Stakeholders in Districts of North Bengal" under RKVY was submitted by UBKV during February, 2019. The original project with proposed cost of Rs. 224.07 lakh has been revised according to observation of ICAR and got clearance vide F. No. 1-29/2019-RKVY, dt. 22/01/2020 and revolving fund has been excluded from budget as per norms of RKVY. The revised approved cost excluding revolving cost has been Rs. 75.45 lakh. Implementing department-Agriculture (UBKV).
- d) Project on "Mechanization of different farms under BCKV for augmentation of quality seed production and supply to the farmers for improving their livelihood" under RKVY- RAFTAAR 2019-2020 with outlay of Rs. 1.96 crore was submitted to SLSC. Subsequently the project has been revised considering reasonableness of cost amounting to Rs. 0.98 crore according to comments of ICAR. Implementing department-Agriculture (BCKV). Status: The project work has been completed.

Decision:

The House accorded post-facto approval of the proposals stated under para 8/(3) (a to d).

# e) Preparation of RKVY-RAFTAAR action plan 2021-22

Govt. of India has recently convened a Desk Review Meeting on RKVY-RAFTAAR with all the States (on 2<sup>nd</sup> & 3<sup>rd</sup> December, 2020). The States were requested to go ahead with preparation of RKVY-RAFTAAR Action Plan for implementation during 2021-22 following existing guidelines and format of DPR. Multi-year projects may also be considered; in the mean time, if there is any changes in guidelines, GOI will communicate the same to the states. It has also been suggested that the States should be ready with RKVY AAP-2021-22 by February, 2021 and convene SLSC meeting by March 2021, so that the States may start implementation of RKVY-RAFTAAR projects from the very beginning of the financial year. The State has also been requested to prepare SAP and SAIDP for the period 2021-22 to 2024-25.

#### Decision:

The House requested all the stakeholder Departments to:

- Submit RKVY-RAFTAAR Action Plan for 2021-22 with supporting DPR in soft & hard copies to the State Nodal Department (Agriculture) by 21<sup>st</sup> January, 2021.
- 2. The State Level Project Screening Committee (SLPSC) will examine the project proposals by 2<sup>nd</sup> week of February, 2021.
- 3. The State Nodal Department will submit Action Plan for 2021-22 under RKVY-RAFTAAR including sub-schemes to GOI for their comments so that the SLSC meeting may be convened time bound manner.
- 4. The Nodal Department will prepare SAP and SAIDP.

# Agenda III) State Extension Work Plan (SEWP), 2020-21, ATMA:

# 1: Approval of State Extension Work Plan (SEWP), 2020-21 ATMA Programme:

Shri H. Mudi, Joint Secretary, Department of Agriculture placed the agenda wise power point presentation.

During 2020-21, State Extension Work Plan (SEWP) under Centrally Sponsored Scheme Sub-Mission on Agricultural Extension (SMAE) has been prepared to the tune of Rs. 13088.3691 Lakh (Rupees One hundred thirty crore eighty eight lakh thirty six thousand nine hundred ten only ) only with 60:40 (GoI: State) ratio.

At present the programme is being implemented in 23 ATMA districts of this State and different activities are being implementedthrough an autonomous institution set up at district level which is registered under Society Registration Actand District Magistrate of the district act as the chairman of the Governing Board (GB) of ATMA. Under this programme, ATMA Functionaries (BTM /ATM etc.) have been recruited at the block level in all the districts and their remuneration is paid from this Programme.

Upon "In-principle" approval by the Chairman, SLSC cum Chief Secretary to Govt. of West Bengal on 30-04-2020, SEWP was submitted to GoI requesting for release of 1<sup>st</sup>instalment of fund during 2020-21 and an amount of Rs.40.53 Crore [GoI Share Rs.24.31 Cr + State Share Rs.16.22 Cr] has been released as 1<sup>st</sup> instalment which has been fully utilized for payment of remuneration and different farmers oriented activities.

Now the SEWP 2020-21 is being submitted for ratification of the SLSC.

#### **Decision:**

The House ratified this and "in-principle" approval accorded by the Chief Secretary.

# 2: Review of Utilisation of fund of ATMA during 2019-20

During 2019-20, an amount of Rs. 62.50 Crore [GoI and State Share together] was released, and has been utilized fully towards payment of remuneration and different farmers oriented activities.

#### Decision:

The House expressed satisfaction over the pace of fund utilization.

Agenda IV) Implementation of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) & Bangla Krishi Sech Yojana (BKSY) in West Bengal:

The CEO & Secretary, WBSWDA placed the agenda-wise points of discussion through power point presentation.

# 1: Post facto approval of Annual Action Plan for 2020-21 under PMKSY:

- i) The Annual Action Plan for PMKSY-Watershed Development amounting to Rs. 136.04 crore was submitted to the Department of Land Resources (DoLR) in Government of India for FY 2020-21 after approval of the Chairman, SLSC on 11/06/2020.
- ii) The Annual Action Plan for PMKSY-Per Drop More Crop amounting to Rs. 103.27 crore including the areas to be covered with Micro Irrigation under 'Namami Gange' amounting to Rs. 3.65 crore was submitted to the Department of Agriculture, Cooperation & Farmers Welfare (DAC&FW) in Government of India for FY 2020-21 on 22/05/2020 after approval of the Chairman, SLSC.
- iii) The corresponding additional top-up subsidy under Bangla Krishi Sech Yojana for small and marginal farmers for the Micro Irrigation Beneficiaries amounting Rs. 68.75 crore out of State Development Scheme was also approved by the Chairman, SLSC in the Annual Action Plan.

The above proposals have been placed before the house for post-facto approval.

#### **Decision:**

The house considered and ratified the decision of the Chairman, SLSC.

#### 2: Action Taken Report on SLSC Meeting held on 10/04/2019:

- i) In compliance of the decision regarding suspension of availing benefits to the Small Tea Growers under Bangla Krishi Sech Yojana (BKSY) in association with PMKSY-Per Drop More Crop, order was issued vide no. 014-19(O)/1(47)/189/IWMP/Est./2014 dated 31/05/2019.
- ii) Top priority has been given on Micro Irrigation development in the Blocks under water stressed rainfed areas and such other priority areas where Micro Irrigation is beneficial and preferable, including the districts of Paschimanchal region, Hill areas, Dooars, Gangetic alluvial zone and Coastal saline belts.

During 2019-20 already 5,734 ha benefitting 14,509 farmers has been implemented including 1833 ha in the Paschimanchal region. Installation for 1,893 ha is in progress. During 2020-21 already 640 ha has been covered in which 1,598 farmers have received the benefit.

#### Decision:

The house reviewed the same and expressed satisfaction on actions taken.

3: Performance appraisal during 2019-20 and 2020-21 under PMKSY-Watershed Development and Bangla Krishi Sech Yojana in association with PMKSY-Per Drop More Crop:

10: Review of implementation of PMKSY 2020-21.

The house has been apprised with the financial performance during 2019-20. The WBSWDA has utilized Rs. 122.97 crore against available Rs. 352.53 crore with 40% utilization in PMKSY-WDC, 30% in PMKSY-PDMC and 26% in BKSY (SDS).

The overall utilization in 2020-21 till 7<sup>th</sup> December is Rs. 126.53 crore against Rs. 266.79 crore. utilization in PMKSY-WDC, PMKST-PDMC and BKSY (SDS) were 56%, 39% and 52% respectively.

#### **Decision:**

The House expressed satisfaction over the improvement of performance in 2020-21 w.r.t 2019-20 in spite of Covid situation.

4: Approval of new Row to Row & Plant to Plant spacing for covering wide range of vegetables and other crops in West Bengal condition for Drip Irrigation as per recommendation by the Technical Committee:

In West Bengal the famers cultivate vegetables in closer spacing than the allowed closest spacing of 1.2 mt x 0.6 mt in Drip irrigation as per Operational Guideline of PMKSY-PDMC. To review of the situation and for recommendation of a suitable spacing for Drip Irrigation in this State, a Technical Committee under chairmanship of Prof. K. N. Tiwari, PFDC, Agriculture & Food Processing Engineering Department, IIT, Kharagpur was constituted with members from FPI & Horticulture Department, Agriculture Directorate and WRID Department. The committee, considering geographical condition, recommended a spacing of 0.6 mt x 0.6 mt for providing Drip

Irrigation on multiple crops grown in the State of West Bengal. The proposal has been placed before the House for consideration.

#### Decision:

The house considered and requested the CEO to take-up the proposal with the GOI to include this in the Guidelines considering the agro-climate situation in the State and the leading role the State plays in vegetable cultivation.

5: Approval and consideration of Agro-climatic Zone Specific Requirement for inclusion of accessories for helping implementation of Micro Irrigation in hilly region alike North Eastern and Himalayan States:

The house was apprised that in the hill areas of Darjeeling and Kalimpong district and parts of Bankura and Purulia district, the Micro Irrigation can be operated using force of gravity for which pressure release valve (PSV) and Manifolds are required. This facility is provided in the BoQ (Bills of Quantity) for the North Eastern and Himalayan region.

The house has been requested to consider and recommend the requirements having similar geographical conditions and to include these items in the BoQ for West Bengal to the DAC&FW, Government of India.

#### Decision:

The house considered the matter and instructed the CEO to take up with the Government of India for allowing the benefit to the small and marginal farmers in the State.

# 6: Consideration of Estimated Cost for Dug Well, Bore Well, etc. as per Agroclimatic Zone, Topography and Geological feature:

The house was apprised of the estimated cost of dug well, bore well etc., in terms of Schedule of Rate (SoR) of PWD, Government of West Bengal, Volume-I, 2017 in different districts of West Bengal which varies based on the geographical location (from Rs. 0.7 to 1.82 lakh per unit) and the same is much above the approved cost norms of Rs. 50,000/- per unit, available as subsidy in the Other Intervention component of PMKSY-Per Drop More Crop; as a result the beneficiary share (project cost premium subsidy of Rs. 25,000/-) becomes very high. The detailed table is placed in the house (Annexure-XIII) with request to recommended the same for inclusion in the central guideline.

#### Decision:

The house considered and instructed the CEO to take up with the appropriate authority in GOI for consideration and incorporation in the Guideline for benefit of the small and marginal farmers in varying geographical locations.

# 7: Ratification of approval of MI manufacturer:

The house has been appraised that, two Micro Irrigation Manufacturer viz. (i) M/s. SRM Plastochem Ltd., Flat No.-3-C, Aparna, Ridhi Siddhi Garden, Diamond Harbour Road, Kolkata and (ii) Mohak Industries Ltd., Plot No.-1, Industrial Estate, Nagar-Pune Road, Ahmednagar have been registered after approval of Chairman, SLSC on file for undertaking works of PMKSY-Per Drop More Crop in terms of Operational Guidelines. The house has been requested to ratify the decision.

#### Decision:

The house ratified the matter.

## 8: Ratification of proposal under PMKSY-Micro Irrigation Fund created under NABARD:

The house was apprised that a project proposal for synchronising existing irrigation sources with Micro Irrigation in the 72 sensitive and very sensitive blocks on use of ground water of West Bengal along with creation of new surface water source amounting to Rs. 291.11 crore was submitted before the Steering Committee constituted by the Department of Agriculture, Cooperation & Farmers Welfare, Government of India after approval of the Chairman, SLSC. The proposal has been sanctioned in its 3<sup>rd</sup> meeting. The house is requested for ratification.

#### Decision:

The house ratified the matter.

9: Consideration of proposal for dedicated Project Monitoring Unit (PMU) at State level and District level for smooth implementation of Micro Irrigation in West Bengal by creating Institutional Setup with engagement of Contractual Manpower under PMKSY-Per Drop More Crop as per existing fund sharing pattern of 60:40.

#### Decision:

The House directed to submit the same following extant procedures.

### (i): Appraisal of PMKSY-Watershed Development project in West Bengal:

a) The house has been apprised on the status of expenditure of 77 Batch-III PMKSY-WDC projects and financial progress of 42 Batch-IV PMKSY-WDC projects in West Bengal as per following table:

The house was apprised regarding a convergence work plan of PMKSY-Watershed Development project in Batch-IV [in the components of Watershed Development Works (WDW) and Livelihood Activities for Assetless Persons (LAAP)] with Panchayat & Rural Development Department (P&RD), Government of West Bengal.

An amount of Rs. 26.28 crore comprising Federation formation (Rs. 6.84 crore), providing Revolving fund to Self Help Groups (Rs. 7.00 crore) and implementation of Watershed Development Work (Rs. 12.44 crore) has been transferred to the SRLM division in P&RD Department after Departmental approval.

The house is requested to ratify the proposal.
