**Sub:- Minutes of the State Level Sanctioning Committee (SLSC) meeting for Centrally Sponsored Schemes of the Agriculture and Allied Department for the year 2021-22 held at the Secretariat Conference Hall, Nagaland on 23.09.2021 at 2:00 PM.**

The State Level Sanctioning Committee (SLSC) meeting for Centrally Sponsored Schemes of the Agriculture and Allied Department for the year 2021-22 was held under the Chairmanship of Chief Secretary, Shri.J.Alam, IAS. The meeting was attended by the members of the State Level Sanctioning Committee including the Finance Department.

At the outset, the Chief Secretary & Chairman SLSC lauded the Agri & Allied Departments for the yeoman service rendered during the Pandemic and emphasized the need for more agriculture activities as more than 60% of the Naga population depends on agriculture for their livelihood. With the State facing a major adversity especially due to the pandemic, deficiency in rain, infestation of Fall Army Worm (FAW) and outbreak of African Swine Flu he called for the need to continuously work to overcome these difficulties. The Chief Secretary also appreciated the Agriculture Production Commissioner (APC) for garnering good cooperation and convergence with the Agri and Allied Departments, and urged the entire line Departments to unite and go in one direction. The Chairman requested APC, Nagaland and Vice Chairman of the SLSC, Shri.Y.Kikheto Sema, IAS to present the agenda before the SLSC for deliberation.

Stating the extraordinary situation due to the Pandemic and drought situation, the APC appealed to all Agri and Allied officials to give extraordinary efforts in delivering materials to the farmers. The proposed Action Plans of CSS 2021-22 were presented to the members of the SLSC for examination and after thorough deliberation, the SLSC members conveyed their approval as under: -

1. **RKVY:-**The APC briefed the members of the SLSC that the proposal with the recommendation of the State Level Technical Screening Committee (SLTSC) was submitted to the Ministry of Agriculture on 18.01.2021 and on receipt of the comments and observations from the respective Divisions, the Annual Action Plan for Rastriya Krishi Vikas Yojana (RKVY-RAFTAAR) for 2021-22 was accordingly revised and incorporated amounting to **₹5932.50 lakh (Rupees fifty nine crore thirty two lakh and fifty thousand)** only, which was approved by the committee. The committee also approved the Scheme to be implemented in 25 clusters, and the geo-tagging of all the clusters along with beneficiary list linked with aadhar will be submitted as and when the project is implemented.
2. **PMKSY-**Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) has 3 main components namely a) Per Drop More Crop (PDMC) b) Har Khet Ko Pani (PMKSY-HKPP) and c) Watershed Development Component 2.0 (PMKSY-WDC.2.0)

a) **PMKSY(PDMC):-Pradhan Mantri Krishi Sinchayee Yojana(PMKSY) Per Drop More Crop (PMDC)** is implemented by two Departments:

- i. Horticulture Department- PMKSY-MICRO Irrigation (M.I)- (60% fund)
- ii. Agriculture Department- PMKSY- Other Interventions (O.I)- (40% fund).

The SLSC approved to submit AAP 2021-22 amounting to **₹9408.67 lakh (Rupees ninety four crore eight lakh sixty seven thousand)** only (₹. 8468.00 lakh as Central Share and ₹. 940.67 lakh as State Share) in the existing ratio of 60% for M.I and 40% for O.I.

Henceforth, from next financial year onwards a consolidated PMKSY-PDMC Action Plan will be prepared jointly by Agriculture and Horticulture Departments and submitted to G.O.I by the Nodal Department (Agriculture Department) with the approval of SLSC and Action Plans for O.I and M.I shall not be prepared for agricultural or horticultural crops/fields per se but shall also cover commercial crops/plantations like Coffee, Rubber, Tea, Oil Palm etc undertaken by other Allied Departments.


b) **PMKSY-HKPP:** The proposal for Pradhan Mantri Krishi Sinchayee Yojana- Har Khet Ko Pani(PMKSY-HKPP) for the current financial year 2021-22, under Water Resources Department was deliberated by the SLSC and the amount of **₹ 28447.66 lakh ( Rupees two hundred eighty four crore forty seven lakh sixty six thousand)** only was approved by the committee.

Chief Engineer, Water Resources Department, highlighted on the 5(Five) years Strategic Action Plan as per State Irrigation Plan (SIP) & District Irrigation Plan (DIP) of PMKSY (2017-2022) where the total CCA utilized till date is 14,656 Ha with a balance of 20,340 Ha. SIP & DIP of PMKSY for the State will be due by April 2022, however, considering the utilization of 42% CCA, he proposed that, the existing SIP & DIP of PMKSY be renewed/ continued to utilize the spill over CCA of 20340 Ha till such time SIP/DIP of PMKSY for the State is formulated, which was approved by the committee.

c) **PMKSY-WDC.2.0:-Annual Action Plan 2021-22 for implementation of PMKSY- Watershed Development Component 2.0(PMKSY-WDC.2.0)** under Land Resources Department amounting to **₹5376.00 lakh (Rupees fifty three crore seventy six lakh)** only was approved by the committee.

3. **MOVCD-NER-Mission Organic Value Chain Development for North-East Region (MOVCD-NER)** is implemented by two Departments and one agency: i. Agriculture ii. Horticulture & iii. NEDFI. The proposal of MOVCD-NER for the year 2021-22 was presented to the members of the SLSC for deliberation and approved the amount of **₹2887.50 (Rupees twenty-eight crore eighty seven lakh fifty thousand)** only by the committee.

4. **ATMA:- The Action Plan for Agricultural Technology & Management Agency (ATMA)** amounting to **₹2512.65 lakh (Rupees twenty five crore twelve lakh sixty five thousand)** only (ie. ₹2233.47 lakh as Central Share, ₹ 279.18 lakh as State Share) was deliberated and approved by SLSC.





5. **NFSM:-** The proposal of National Food Security Mission (NFSM)- Crops & Commercial Crops-Jute for the year 2021-22 was presented to the members of the SLSC for deliberation and the amount of **₹1507.00 lakh (Rupees fifteen crore seven lakh)** only was approved by the committee.
6. **NMEO-OS&OP:-** With the launching of the new scheme National Mission of Edible Oil -Oilseeds & Oil Palm (NMEO-OS&OP) the proposal for NMEO-OS&OP for the year 2021-22 was presented to the members of the SLSC and deliberated at length.
- Oilseed:-** Action Plan of NMEO-oilseed 2021-22 amounting to **₹194.44 lakh (Rupees one crore ninety four lakh forty four thousand)** only was approved by the committee.
  - Oil Palm:** The scheme was earlier known as National Mission on Oilseeds and Oil Palm (NMOOP). The State Government has signed two MoU with Shivasais Oil Palm Private Ltd, Andhra Pradesh on 11<sup>th</sup> Sept 2014 for 150000 ha and on 11<sup>th</sup> August 2015 for 100000 ha. covering a total area of 2,50,000 ha. Perhaps, the MoU was signed without taking into account of non viability of Oil Palm plantation in the Jhum cultivation. Although, the area covered was 4627 ha. From as per the record, it was found that many farmers has abandoned their plantation due to high maintenance cost, logistics problems and negative influence from social medias, and on actual assessment the area covered was found to be 1126.91 ha. And since the potential area has already been covered by other commercial crops like teak, agar, rubber, tea, areca nut and coffee etc. and on the basis of the review meeting held on 18.08.2021 with CEO, Shivasais Oil Palm.Ltd, it was decided to initially project the cultivation area to only 15000 ha in cultivable wasteland and was conveyed to the members of SLSC. It was decided that some of the cost norms are very meagre, hence the committee decided to request the Government of India to increase the cost norms and also provide logistics support such as roads. Action Plan for 2021-22 amounting to **₹3244.80 lakh (Rupees thirty two crore forty four lakh eighty thousand)** only was approved by the committee.
7. **NMSA:-** The proposal of National Mission on Sustainable Agriculture (NMSA) for the year 2021-22 was presented to the members of the SLSC for deliberation and approved the amount of **₹1344.45 lakh (Rupees thirteen crore forty four lakh forty five thousand)** only (₹.1210.01 as Central Share and ₹.134.44 as State Share) . The Scheme covers the following sub-scheme

8. **SMSP:-**The committee decided to increase the production of certified / quality seeds and upgrade the quality of farm saved seeds. The proposal of Sub-Mission on Seeds & Planting (SMSP) under National Mission on Agricultural Extension and Technology Management (NMAET) for the year 2021-22 was presented to the members of the SLSC for deliberation and the amount of **₹238.68 lakh (Rupees two crore thirty eight lakh sixty eight thousand)** only was approved by the committee.
9. **SMAM:-** On the issue of machineries the Chief Secretary stated that, it should not only benefit the individual farmer but the whole community. The proposal of Sub-Mission on Agriculture Mechanization (SMAM) for the year 2021-22 was presented to the members of the SLSC for deliberation and approved the amount of **₹6442.56 lakh (Rupees sixty four crore forty two lakh fifty six thousand)** only (i.e. ₹ 5798.49 lakh as Central Share and ₹ 644.07 lakh as State Share). The Action Plan of SMAM for Aspirational District amounting to **₹107.50 lakh (Rupees one crore seven lakh fifty thousand)** only was also approved by SLSC.
10. **RPS-RKVY:-** The proposal of Reclamation of Problem Soil (RPS), a sub-scheme of RKVY for the year 2021-22 was presented to the members of the SLSC for deliberation and approved the amount of **₹111.11 lakh (Rupees one crore eleven lakh eleven thousand)** only (i.e ₹ 100.00 lakh as Central Share and ₹ 11.11. lakh as State Share).

In his concluding remarks, the Chief Secretary requested the Departments to make an impact study of the schemes and programs implemented and to properly utilize the funds allocated to the Departments through proper supervision and monitoring over the activities of the programmes. The meeting ended with a vote of thanks from the chair.


