The Joint Secretary, Government of India informed that "the comments of Department of Agriculture and Cooperation, Government of India on each item have been obtained and copy has been given to Agricultural Production Commissioner & Secretary to Government. Those comments may be taken into account while taking up discussion on the individual items. He also added that the projects for which comments are not received, GOI norms should be strictly followed". To this, APC informed the Committee that the Additional Agenda Book No.4 pertaining to 14 items have been communicated to the members on 16th March 2013 and comment was received from Department of Agriculture & Cooperation, Government of India on 18.3.13:

Minutes of the 10th Meeting of the State Level Sanctioning Committee of the National Agriculture Development Programme held on 19.03.2013

The 10th meeting of the State Level Sanctioning Committee for the National Agriculture Development Programme was held on 19.03.2013 under the Chairmanship of the Chief Secretary at the Chief Secretary's Conference Hall, Secretariat, Chennai. The Agricultural Production Commissioner and Secretary to Government welcomed the Chief Secretary, Joint Secretary, Government of India, Commissioner (Animal Husbandry), Government of India, and other participants. The Agricultural Production Commissioner then made a presentation about the overview of the National Agriculture Development Programme implemented in the State since inception and presented the achievements of implementation of projects approved for previous financial years as well as for the current year as on 15.03.13 to the forum. The performance details and the list of participants are given in Annexure I & II

The Joint Secretary, GOI, pointed out that the overall fund allocation for RKVY for the year 2013-14 is not likely to be increased much and the States may expect same amount as allocated during last year- 2012-13, however, actual allocation would be made as per the NADP funds allocation guidelines. Further he remarked that there should be transparency in giving scheme benefits and assets creation. Geo-referencing of various assets created under NADP may be done and information may be uploaded to the website so that anybody can access it and see the details of projects taken up and also overlapping of the projects can be avoided.

Agricultural Production Commissioner & Secretary to Government informed that Hon'ble Chief Minister of Tamil Nadu has launched a scheme benefits tracking system in Tamil Nadu on AGRISNET portal of Agriculture Dept. on which project of special Delta package taken under NADP 2012-13 have been fully captured. He called upon the HODs to periodically update the information on the portal to keep it up to date and suggested that in next SLSC the site may be shown to the committee.

Commissioner, Animal Husbandry, GOI suggested that about 40% of the total allocation should be allotted to Allied Sector. Agricultural Production Commissioner & Secretary to Government replied that the Commissioner, Animal Husbandry has

Further, in the covering letter of GOI communicating the project-wise comments, it has been mentioned that "The total cost of projects to be considered in this meeting should not exceed the allocation of the State during 2012-13 as the allocation for the State for 2013-14 has not been finalized." Last year allocation of Normal RKVY was Rs.591.50 Crs and Sub schemes was Rs.78.18 Crs.

Further it was communicated about Additional Agenda Book No 4 that "As the Agenda Item was received in DAC on 18.03.2013, 15 days time as stipulated in para – 5.4 of RKVY guidelines was not available. As such these projects may not be included for discussion in the SLSC meeting to be held on 19.03.2013."

The Agricultural Production Commissioner & Secretary to Government informed that Project Proposal No.10.A.1 "Uzhavar Peruvizha", Project Proposal No.10.A.29 No.10.A.10 "Integrated Farming System" and Project Proposal No.10.A.29 "Provision of diesel engine pumpsets with Raingun / Portable Sprinkler Irrigation "Provision of new items, since these projects were already included in Main System" are not new items, since these projects were already included in Main Agenda as Proposal No.10.A.1, 10.A.10 and 10.A.29 (Agenda Book No.1) which are resubmitted with some modifications and further elaborations in additional Agenda booklet No-4.

For other proposals it was informed by the Agricultural Production Commissioner & Secretary to Government that other additional Agenda Book-4 projects are primarily new initiatives using innovative approach which are being introduced to bring in paradigm shift in Agriculture Sector of the State and the discussions about these projects were held at the highest level only during last week. Therefore the Additional Agenda could be circulated only on Saturday (16th March 2013) and APC requested the committee to consider these projects as in the past SLSC meetings, many proposals have been taken as Table Agenda and based on the merit of the projects, decisions were taken.

The Chief Secretary stated that only very important proposals are being taken in this SLSC considering that the scheme benefit should reach to the farmers well in time, and agreed to restrict the project approval only upto last year's allocation, therefore on merit these proposals in Additional Agenda Book No 4 need to be taken up. Further, because of limiting the amount to last year's allocation, it becomes inevitable to defer many project proposals. However certain proposals,

due to its importance and urgency, may be discussed in detail and agreed in principle which may be taken up if additional allocation is received or if any saving amount is available. The Joint Secretary, GOI informed that additional agenda new proposals may be considered in the SLSC subject to the condition that they are in conformity with the GOI norms and the observations of Department of Agriculture & Cooperation, Government of India, if any, may be incorporated suitably into these projects. The committee then took up the subjects for discussion.

Agricultural Production Commissioner & Secretary to Government highlighted the salient features of Uzhavar Peruvizha and explained the benefits and output of this programme conducted during last year.

Then the subject was discussed in detail taking into account the comments of extension division, GOI.

APC informed that for training of a farmer Rs.400 per farmer per day is eligible as per ATMA guidelines which includes the travel and boarding cost. Even if we exclude Rs.

250/- towards the travel and boarding cost Rs. 150/- may be spent towards training each farmer. Uzhavar Peruvizha 2013 proposes to train 40 Lakh farmers with the project cost of Rs 4592 Lakh which works out to Rs. 115 per farmer per day, well within the ATMA guidelines. During last year, the actual number of farmers attended were 38 Lakhs. Farmer specific training in various aspects of Agriculture and allied sector is proposed to be given. Proper attendance of the famers participated in this year Uzhavar Peruvizha programme will be taken and the same would be put up on web site also.
