The details of the project under RKVY-RAFTAAR (both normal & sub-schemes) approved in the SLSC for an amount of ₹1087.1927 crore are shown in APPENDIX-'B' as component-wise and Department-wise shown in ANNEXURE-'I', 'II', 'III', 'IV', 'V', 'VI', 'VII', 'VIII' in respect of Agriculture and allied department for implementation of the RKVY-RAFTAAR project during the year 2019-2020. Also project approved for ₹19.5016 crore under State Extension Work Plan (SEWP) under National Mission on Agriculture Extension Technology (NMAET), shown in ANNEXURE-'IX'. 

MINUTES OF THE MEETING OF STATE LEVEL SANCTIONING COMMITTEE (SLSC) HELD IN
THE CONFERENCE HALL OF THE CHIEF SECRETARY, 5TH FLOOR, BLOCK-II, CIVIL
SECRETARIAT, ITANAGAR ON 31ST JULY 2019

1. The State Level Sanctioning Committee (SLSC) meeting of RKVY-RAFTAAR Schemes was held on 31st July 2019 under the Chairmanship of the Chief Secretary, Govt. of Arunachal Pradesh. The meeting was attended by the members from Agriculture and its allied Sectors and a representative from the Ministry of Agriculture, Cooperation & Farmers Welfare, Govt. of India, Mr. Ganesh Singh, Under Secretary (RKVY), and Mr. Prabhat Kumar (Consultant), RKVY Division, Department of Agriculture & Cooperation, Govt. of India to consider and approve the Project Proposals of Agriculture and allied Departments under Normal Rashtriya Krishi Vikash Yojana (RKVY), Sub-scheme (RKVY) for Reclamation of Acidic Soil and SEWP (State Extension Work Plan) under NMAET (National Mission on Agriculture Extension Technology). List of the participants is given at Appendix "A".

2. While welcoming the members present in the 11th SLSC meeting, the Director (Agriculture), Govt. of Arunachal Pradesh, Mr. Anong Lego, appraised the house about the aims and the objective of the SLSC meeting and informed that this SLSC is to approve two important Centrally Sponsored Schemes (CSS) as namely:-
 - (A) Normal scheme of Rashtriya Krishi Vikash Yojana (RKVY)-RAFTAAR,
 - (B) Reclamation of Acidic Soil under sub-scheme of RKVY-RAFTAAR
 - (C) The State Extension Work Plan (SEWP) under NMAET (National Mission on Agriculture Extension Technology).

3. At the beginning of the Power Point Presentation from the Agriculture Department on the status of RKVY fund released to Arunachal Pradesh, the Chief Secretary –cum-Chairman (SLSC) expressed concern over the declining trend of fund flow from GOI in spite of state having vast potential to develop Agri. & allied Sectors. He informed the house how the States of Meghalaya are supported with huge fund for AHV&DD and Fisheries. After brief discussion with the representatives of GOI, the Chief Secretary-cum-Chairman (SLSC) suggested the Agri. and allied Department to propose projects as per the needs of the State not as per the RKVY-RAFTAAR Operational Guidelines. All the Agri. & allied Departments especially, Veterinary, Fisheries and Horticulture were asked to raise the quantum of project proposals. While, the poor, small and marginal farmer should be benefited, however at the same time, priority for the project requiring high farmer contribution share should be given to one who can bear the contribution.

It was discussed and agreed that in order to achieve the target of doubling the farmer's income by 2022, the cost norm prescribed in all the Centrally Sponsored Scheme should be revisited by the Ministry of Agriculture, Cooperation & Farmers Welfare. The subsidy rate prescribed for 50:50% should be proposed for 75:25% or 80: 20% in order to enable the small and marginal farmers to take up the scheme in the State. The poor farmer cannot bear the farmers share and the lending banks never give loan to them. The representatives of GOI has assured to personally pursue with the Agriculture, Cooperation & Farmers Welfare, GOI in this regards.

The Department of Agriculture, Govt. of Arunachal Pradesh proceeded with the Power Point Presentation on the project proposals under Normal RKVY, Sub-scheme of RKVY and SEWP- 2019-2020 for further discussion. The project proposal under Agriculture Department was presented by the Director (Agriculture) through PPT and the house approved all the proposal as proposed with some minor modification. The

modification in the proposal were i) construction of PD ATMA-cum-DDA office at Farmers Training Centre (FTC) Ziro instead of Longding. ii) the fund proposal for preparation of District Agriculture Plan (DAP) and State Agriculture Plan (SAP) approved for Rs. 1.50 crore shall be kept from the overall head of fund that shall be received from the Govt. of India, iii) the No. of Vermi-compost unit shall be raised to 500, iv) the uniform hand tools kit shall be provided under the scheme in the State and

v) Proposal for District Level Expo-cum-Sale Exhibition shall be replaced for State Level Expo-cum-Sale Exhibition for an amount of Rs.1.00 crore.

The project on NADEP compost pits in Aspirational district of Namsai has been constructed during *Krishi Kalyan Abhiyan* in the year 2018-19 against the fund allocated. The construction was approved in the SLSC 2018-19 and was submitted to the DAC&FW but the earmarked fund has not been released by the GOI although physical target is achieved. In view of non-release of fund to the State, the DAC&FW is requested to release the fund of Rs. 12.60 lakh in addition to normal RKVY fund to the Agriculture Department to enable settlement of pending liabilities during the current financial year 2019-20.

4. The power point presentation on project proposal under Department of Horticulture was presented by Mr. J Rime, Director. He clarified the comments from GOI and explained in details the basis and requirement of project proposed with representatives from GOI. The Dept. has been suggested to provide benefits to small and marginal farmers only. While proposing similar project as vermi composting in other allied dept. care should be taken that the same beneficiary is not selected by both the departments. The SLSC have approved i) 130 units of Vermi compost, ii) Electric drier 100 units @ Rs. 7.00 lakh and iii) provide 20 Nos. carats each to farmers. Proposals for Anti Hail Nets, Ladder, and Support to Horticulture & Forestry College, training and exposure visit have been dropped and the Dept. was suggested to propose the same amount for promoting Vegetable as cash crop in temperate belts and location specific expansion programme of Kiwi fruit on cluster basis in the state.

However, the Department was advised to revalidate the unspent balance of 2018-19 funds pending against their dept. and submit Utilization Certificate within 4 month to access RKVY fund during 2019-20.

5. Dr. T. Taku, Joint Director, Department of AH & Veterinary & DD presented PPT on the project proposal of the Department. The member expressed concerned over the non receipt of comments from the DAHD, Gol on some of the project proposals especially the project proposal for cultivation of local tree fodders, commonly relished by livestock's intercropped with perennial grasses to provide animal feeds round the year. Since this is an indigenous and a new method appreciated by all animal lovers in the state and was previously supported under RKVY and is an ongoing project, the proposal is approved for an amount of Rs. 30.00 lakh for 6 unit @ Rs. 5.00 lakh each by the SLSC member irrespective of comments from DAHD.

The project proposal of i) Medicine store building at Borum, Chiyang Tajo and ii) construction of Veterinary Aid Centre building-cum-Medicine store at Soki, Denwe and Jeko iii) proposal for Goatary in 15 districts with 10 units each iv) 250 units for Mithun have been approved by the SLSC. The Department was also directed to prepare a separate proposal for 500 units of piggery in the line of Meghalaya Govt. for submission to the Department of Agriculture Cooperation & Farmers Welfare, Govt. of India. After thorough discussion, all the project proposals were approved by the member with minor change/modification. The minor modifications were on the cost norms as prevailing in the state with increased fund except the proposal for Brucellosis control programme under special sub-scheme of RKVY fund since there is another special programme launched by the Ministry of Agriculture Cooperation & Farmers Welfare, Govt. of India. The department

was suggested to furnish the Utilization Certificate of unspent balance of 2018-19 RKVY fund within 3 months.

6. There were certain suggestions for Department of Fisheries by the Chief Secretary and Agriculture Production Commissioner (APC) on project proposals and DPRs as follows:-
 - i. The project proposal for construction of fish seed rearing unit amounting to Rs.100.00 lakh was suggested to be increased to an amount of Rs. 600.00 lakh. This will enable the Department to cover more number of marginal beneficiaries under the scheme.
 - ii. Regarding construction of hygienic Fish Market, it was suggested that the numbers of hygienic Fish market be reduced from 15 to 2 Nos and cost per unit to be increased from Rs. 10.00 lakh/unit to Rs.40.00 lakh/unit.
 - iii. Regarding the proposal for construction of fish feed Mills, the Chief Secretary and Agriculture Production Commissioner desired allocation of bigger amount and limited targets, which will give better outcome. The feed Mill has been decided to be constructed at Lower Dibang Valley Dist. which is centrally located for an amount of Rs. 200.00 lakh.
 - iv. The numbers of Raceways to be constructed are to be made accurate in accordance with the amount allotted.
 - v. The State Dept. of Fisheries was further suggested to propose additional special package to the Gol for an amount of Rs.1000.00 lakh (one hundred crore).
7. The proposal under Textile and Handicrafts Department were presented by Smti. Barnali Sur, Joint director. It was suggested to propose beneficiary oriented project and limit the numbers of project proposals on priority. It was also advice to submit specific fresh proposal for development of Eri & Muga Silk Development in the State. Accordingly, as per advice, fresh proposal of Rs. 523.95 was prepared and approved by the SLSC member.
8. Project proposal under Soil and Water Conservation Dept. was presented by Sri. Joram Pupa, Director, State Land Use Board (SLUB, RWD). The department had proposed proposals for an amount of Rs. 11.53 Crore as cleared by the State Level Project Screening Committee (SLPSC) Meeting, however after discussion, SLSC approved proposals for amount of Rs. 10.60 Cr only. The SLSC opined that project that, projects that deals with treatment of soil for improvement as that of the Acidic soil treatment scheme in Agriculture Dept., are to be implemented in crop. The soil and water conservation treatments in catchment areas are to be done by the RWD Department to avoid duplication. The RKVY Sub-scheme for reclamation of acidic soil programme was allotted to Agriculture Department by GOI. The State Land Use Board (SLUB, RWD) are to propose fund required for reclamation of acidic soil treatment from normal RKVY fund within the earmarked amount allotted to them as observed and commented by GOI. The Prevailing cost norm in the state is to be followed for implementation of SALT (Sloping Agriculture Land Technology) in the identified districts. SLSC approved proposals for construction of Boundary wall at existing composite nursery at Karsingsa for an amount of Rs. 128.00 lakh only.
9. An amount of Rs. 297.87 lakh was approved by SLSC for Cooperation Department. The dept was directed to follow the APSR, APPWD cost norm in construction of Agricultural Godown in the State. These project proposed areas should be geo-tagged and proper storage facilities should be incorporated in the Godown. The department agreed to submit the U.C of last year's fund within six month time. In addition to 5(Five) ongoing projects, the project proposal for construction of Agricultural Godown for Changlang LAMPS Ltd. at Changlang under Changlang district was approved.

10. Approval of State Extension Work Plan (SEWP) 2019-2020 for ATMA

- A. The SLSC was of the opinion that the annual State Extension Work Plan (SEWP) for ATMA should adopt uniform fund proposal and allocation corresponding with numbers of CD Blocks under respective ATMA districts. Therefore, to maintain uniform fund projection and subsequent fund allocation, the SEWP for current financial year 2019-20 was re-casted amounting to Rs.1950.16 lakh. The proposed SEWP as per Gol's ATMA operational guidelines- 2018 amounting to Rs.1950.16 lakh at ANNEXURE-IX was considered and approved by SLSC for its implementation during current financial year.
- B. The SLSC also approved the proposal put forth for operationalization of State Agriculture Management & Extension Training Institute (SAMETI) at Pasighat, East Siang District with the engagement of following eligible numbers of functionaries as per set norms in the Gol's operational guideline for ATMA -2018:
1. Director, SAMETI - 1 No.
 2. Deputy Director/ Faculty - 8 No.
 3. Accountant-cum-Establishment Clerk - 1 No.
- C. A fully functional SAMETI with engagement of approved manpower as per operational guidelines of ATMA will ensure regular training and skill up gradation of State and District/ Block level extension functionaries and also reach out to the grass root level extension functionaries and farmers through field visits.
- D. Further, SLSC directed the State Dept. of Agriculture to initiate and adopt process for payment of remuneration / wages on regular monthly basis to all contractual functionaries engaged under ATMA programme in the State Department of Agriculture since, non-payment of salaries on monthly basis adversely affect the work efficiency of engaged field functionaries and hinder their optimal performance. It was also decided that this matter related to payment of salaries on monthly basis shall be taken up with the State Finance department on priority and shall be done same in line with the current arrangement adopted in the State for salary payments of contractual staffs as done in SSA and also other State Govt. Departments.
- E. For honorarium of Farmer Friend under ATMA, it was decided to request Department of Agriculture Cooperation & Farmers' Welfare, MoA & FW, Govt. of India to consider fund sharing pattern of 90:10 basis between Center and State instead of the current fund sharing of 50:50 between Centre and State.


