Sub:- Minutes of the State Level Sanctioning Committee (SLSC) meeting for RKVY and other CSS programmes - 2020-21 held at the Conference Hall of the Chairman SLSC & Chief Secretary, Nagaland on 22.06.2020 at 10:00 A.M.

The State Level Sanctioning Committee (SLSC) meeting for RKVY and other Centrally Sponsored Schemes for the Agriculture and Allied Department 2020-2021 was held under the Chairmanship of Chief Secretary Shri. Temjen Toy. The meeting was attended by the State Planning & Co-ordination Department, Finance Department, Administrative Heads of Departments and Heads of Agriculture & Allied Departments including the 3(Three) Missions along with the respective Programme Officers of Agri & Allied Departments.

The Chairman informed the members of the SLSC that due to the COVID-19 pandemic the SLSC could not be held in time nor could the SLSC members from the Ministry of Agriculture as well as outside Kohima could attend the meeting.

The Chairman requested the Agriculture Production Commissioner, Nagaland Shri. Y. Kikheto Sema, IAS to present the proposals before the SLSC. The APC stated that few proposals of the Department has been submitted to the Ministry of Agriculture after obtaining approval of the Chairman and Chief Secretary, Nagaland in principle. He also informed the members that the proposals submitted to the SLSC is as per the revised and approved allocation of the Ministry of Agriculture. The APC further gave a brief review of the CSS schemes for 2019-2020.

With the permission of the Chairman, the APC put forward the proposals to the members of the SLSC for examination and after thoroughly deliberation on the Action Plans for 2020-21 proposed by Agriculture Department and conveyed the approval of the SLSC Committee as under:-

1. **RKVY:-** The APC briefed the members of the SLSC that the proposal with the recommendation of the State Level Technical Screening Committee (SLTSC) was submitted to the Ministry of Agriculture on 24th February 2020 and on receipt of the comments and observation from the respective Divisions, the Revised Annual Action Plan for Rashtriya Krishi Vikas Yojana (RKVY-RAFTAAR) for 2020-2021, was accordingly revised and incorporated amounting to Rs.3800.00/- lakh (Rupees Thirty-eight crores) only.
2. **NMSA-RAD:-** The APC informed the members that the initial proposal for the National Mission on Sustainable Agriculture for Rainfed Area Agriculture Development was submitted to the Ministry of Agriculture with the in principle approval of the Chairman of the SLSC amounting to Rs.2800.00 lakh. However the Ministry of Agriculture has revised the fund allocation to Rs.1150.00 lakhs, for which the revised proposal for NMSA-RAD is submitted for approval. The SLSC after deliberation approved the proposal amounting to Rs.1150.00 lakhs (Rupees Eleven Crores fifty lakhs) only.
3. **NMSA-SMAF :-** The APC sought the approval of the SLSC for the proposal on Sub-Mission on Agro Forestry (SMAF) under National Mission on Sustainable Agriculture of which was earlier approved in principle by the Chairman of the SLSC, amounting to Rs.200.00 lakhs (Rupees two crores) only.

4. **PMKSY** :- The proposal of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) for the year 2020-2021 was presented to the members of the SLSC for deliberation and approval in respect of the following Departments.

The SLSC after thorough deliberation approved the proposals of the above four mentioned Departments amounting to **Rs.32435.26 lakhs** (Rupees Thirty-two thousand four hundred thirty five lakhs and twenty-six thousand) only.

The Chief Secretary & Chairman concluded the meeting thanking all the members present in the meeting.
