

**Minutes of the virtual meeting of the State Level Sanctioning Committee (SLSC) of RKVY, held at 4.00 PM on 18<sup>th</sup> December, 2020 in Video Conference Hall, New Secretariat Building, Capital Complex, Agartala, Tripura through Video Conferencing.**

---

The meeting of the State Level Sanctioning Committee (SLSC) of RKVY was chaired by the Chief Secretary, Tripura. The Secretary, RD, Panchayat, Finance, Planning, Tripura ; Advisor (Horti), Dy. Secretary (DM) and Under Secretary (RKVY), Ministry of Agriculture and Farmers Welfare, Govt. of India and other members of SLSC were also present in the meeting. The list of participants in the meeting is given at **Annexure-I**.

2. The Director, Agriculture, Tripura welcomed Chief Secretary and all other members of the SLSC and initiated the discussion for consideration of the project proposals of 2020-21 and to review the implementation of projects sanctioned during the year 2018-19 & 2019-20.
3. The Director, Agriculture, Tripura has made a presentation in detail showing sector-wise; project-wise present status of implementation of different projects, release of fund from GOI, fund utilized, utilization certificate submitted to GOI, and the projects undertaken during 2020-21.
4. After detailed discussion, following decisions have been taken in the meeting –
  - A. The SLSC has approved 20 (twenty) projects for an amount of Rs. 5796.062 lakh, which have been supported by MoA&FW, GOI. The Chief Secretary, Tripura has requested the representatives of the GOI for early release of Rs. 3070.76 lakh for completion of seasonal projects which have already been under implementation in field. (Detail Approved Projects is given at **Annexure-II**)
  - B. During 2018-19 & 2019-20 respectively an amount of Rs. 66.67 crore & Rs. 54.70 crore was received from GOI as Central share, out which, utilization certificate have already been sent to Govt. of India for Rs. 64.33 crore ( 96%) & Rs. 40.60 crore ( 74%) respectively.
    - i. A DO letter may be written by Hon'ble CM, Tripura to the Hon'ble Minister, Agriculture & FW, GOI with request to increase the allocation under RKVY Scheme and also for early release of the allotted amount under RKVY Scheme during 2020-21.
    - ii. The Chief Secretary, Tripura advised to undertake next year projects by considering short-term useful projects, production orientation projects so that fund is spent smoothly and utilization certificate can be submitted to GOI in time.

- iii. The Chief Secretary, Tripura instructed all the Agri. & Allied Departments to utilize all pending fund as early as possible and submit 100% utilization certificate to the Nodal Department for onward transmission to the MoA&FW, GOI.
- C. All the Line Departments will take initiatives for regular data entries in the RDMIS portal and also to complete Geo-tagging of the assets created under RKVY Scheme.
- D. Projects for the year 2021-22 will be submitted by last week of March, 2021. Total project cost may not increase by more than 10% over last year allocation. It was advised to examine and find out easily implementable infrastructure and production oriented projects to complete within a time frame.
- E. The Chief Secretary, Tripura has also instructed to write to the Ministry requesting revision in the guidelines of sharing pattern of infrastructure, production oriented & flexi fund provisions so that the easily implementable production oriented projects can be taken in the ensuing years.
- F. The Chairman, SLSC requested to GOI representatives for increasing the allocation under RKVY Scheme and also for early release of the allotted fund under RKVY Scheme during 2020-21 for completion of the projects which are already under implementation.

The meeting ended with vote of thanks to the chair.




